Sub: To lodge FIR against Ramranjan Kansari, S/O- Lt Sabar Kansari of Vill- Kashipur, PS – Kashipur, Dist – Purulia, defecto complainant of Kashipur PS Case No 147/22 dated 14.12.22 u/s 406/420/120B IPC.

Sir,

The nub of the fact in a nutshell is that on 14.12.2022 at 13.05 hrs received a court complaint of one Ramranjan Kansari S/O Lt Sabar Kansari of Vill- Kashipur, PS – Kashipur, Dist – Purulia, duly forwarded by Ld ACJM Raghunathpur Court, to the effect that the complainant has a Video Hall style as "Maa-Tara Chitrayan" formerly known as "Janata Talkies" at plot no 963, Moua - Rangiladih, PS Kashipur Dist - Purulia . On 23.09.2008 one Anupam Chakraborty, S/O- Lt Subodh Chakraborty and Sushil Kr Das Modak, S/O-Lt Khudiram Das Modak both of Kashipur, Dist.- Purulia made a deed of lease fraudulently by putting false signature with Goutam Sen , S/O- Sridhar Sen of BB Das Road Purulia. Since then the said Goutam Sen was running the video Hall without any entertainment tax to Govt. regularly and he was running the said video Hall without valid license and that for tax dues Rs is 31110/-. Over this started Kashipur PS Case No 147/22 dated 14.12.22 u/s 406/420/120B IPC and as per endorsement of O.C Kashipur P.S I, SI Gourango Roy took up investigation of this case.

During investigation after collecting available PS records it came to know that previously three cases have been registered by Ram Ranjan Kanasari on the same ground and same Plot No vide Kashipur PS Case No – 68/09 Dated- 15.12.09 U/S- 447/341 /323/506/34 IPC and ended the Case in FRF Vide FRF No-07/10 Dtd- 10.03.10 and second times Kashipur PS Case No- 47/16 Dated-17.05.16 U/S- 420/406/120B IPC which was ended in FRMF Vide FRMF No-56/16 Dtd- 28.07.16 and third times also Kashipur PS Case No-40/23 Dated – 14.03.23 U/S – 420/406/427/511/120B IPC.

During investigation the prima facie charge U/S 420/406/120B IPC did not established against the FIR named persons but revealed that the Complainant Ram Ranjan Kansari is a petition monger and always submitted petition here and there and harassed the owners of said land and he registered the case only for taking revenge and the allegation made is totally false and motivated.

After collecting sufficient evidences I have submitted final Report of this case vide Kashipur PS FRF No - 61/23 Dtd- 30.04.23 in this case with a prayer for submitting Prosecution report u/s 211 IPC against the complainant Ram Ranjan Kansari, S/O- Lt Sabar Kansari of Vill – Kashipur, PO – P.K. Raj, PS – Kashipur, Dist – Purulia.

Today i.e. 25.09.23 received Order sheet dated 28.08.23 of Ld ACJM, Raghunathpur Court to the effect that Ld Court is accepted the FRF of this case also dropped the case and directed to OC, Kashipur PS to draw FIR against the defecto complainant Ranjan Kansari S/O Lt Sabar Kansari of Vill – Kashipur, PO – P.K. Raj, PS – Kashipur, Dist – Purulia.

Hence, I do hereby lodge this complaint to start a specific case against Ramranjan Kansari S/O Lt Sabar Kansari of Vill- Kashipur, PS – Kashipur, Dist – Purulia u/s 211 IPC read with section 406/420/120B IPC.
