I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Parikshit Kumar, S/O-Rangalal Kumar of Vill- Beradih, P.S- Kotshila, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 28.09.2023 at about 11.45 A.M I, Sri Rabindranath Das, AE & Station Manager, Joypur CCC along with 01. Raushan Kumar, JE(E) Gr-II, Joypur CCC, 02. Ganesh Mahato, Gr-I TSH, Joypur CCC, and 03. Shibaram Mahato, Gr-I TSH entered the premises of Parikshit Kumar, S/O-Rangalal Kumar of Vill- Beradih, P.S- Kotshila, Dist- Purulia and found that Parikshit Kumar, S/O-Rangalal Kumar was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through red colour PVC copper wire 1 sq mm twin wire with hooking arrangement (approx 12 mtr) by means direct hooking to his domestic premises and connected load found 0.210 KW. As that Parikshit Kumar, S/O-Rangalal Kumar committed theft of electric power, I seized the following articles after preparing the seizer list in presence of 01. Raushan Kumar, JE(E) Gr-II, Joypur CCC, 02. Ganesh Mahato, Gr-I TSH, and 03. Shibaram Mahato, Gr-I TSH Joypur CCC. The inspection team left the premises at 12.10 P.M.

01. Red colour PVC copper wire 1 sq mm twin wire with hooking arrangement (approx 12 mtr). Parikshit Kumar, S/O-Rangalal Kumar of Vill- Beradih, P.S- Kotshila, Dist- Purulia has committed an offence U/S 135(i) (a) Electricity Act, 2003 (Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
