I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Sailendra Kumar, S/O-Late Harku Kumar of Vill- Beradih, P.S- Kotshila, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 28.09.2023 at about 12.10 P.M I, Sri Rabindranath Das, AE & Station Manager, Joypur CCC along with 01. Raushan Kumar, JE(E) Gr-II, Joypur CCC, 02. Ganesh Mahato, Gr-I TSH, Joypur CCC, and 03. Shibaram Mahato, Gr-I TSH entered the premises of Sailendra Kumar, S/O-Late Harku Kumar of Vill- Beradih, P.S- Kotshila, Dist- Purulia and found that Sailendra Kumar, S/O-Late Harku Kumar was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through black colour PVC 2-core alluminium cable 4 sq mm with hooking arrangement (approx 22 mtr) by means direct hooking to his domestic premises and connected load found 0.180 KW. As that Sailendra Kumar, S/O-Late Harku Kumar committed theft of electric power, I seized the following articles after preparing the seizer list in presence of 01. Raushan Kumar, JE(E) Gr-II, Joypur CCC, 02. Ganesh Mahato, Gr-I TSH, and 03. Shibaram Mahato, Gr-I TSH Joypur CCC. The inspection team left the premises at 12.35 P.M.
