Sir,

In producing here with one accused person Tarani Sardar (40) S/O Lt- Dibakar Sardar of village- Dhanara, PS- Manbazar, Dist- Purulia along with following seized articles viz- 20 (Twenty) Ltrs. ID liquor within a Plastic Jarikane and 10 pieces plastic glasses and 375 I.D. liquor collected from the jarikane as sample.

I S.I. Sanjib Kr. Chatterjee of Manbazar PS do here by lodged a complaint against accused namely Tarani Sardar (40) S/O Lt- Dibakar Sardar of village- Dhanara, PS- Manbazar, Dist- Purulia to the effect that today (23.09.2023) at 16:05 hrs. I received a telephonic information from a reliable source that one Tarani Sardar (40) S/O Lt- Dibakar Sardar of village- Dhanara, PS- Manbazar, Dist- Purulia was stocked ID liquor illegally at his house and selling the same to hike price for his personal gain. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/ 888 Subhasis Hansda, HG/1419 Shantanu Dutta rushed to the spot for raid by Govt. vehicle. At about 16:45. myself along with force reached at Dhanara village and held raid in the house of Tarani Sardar and found that he is selling ID liquor at the courtyard of his house and Seeing the police party some persons fled away and said Tarani Sardar tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly signed by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Tarani Sardar (40) S/O Lt- Dibakar Sardar of village- Dhanara, PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
