In producing here with one accused person Manik Bairagi (47) S/O Lt- Raju Bairagi of village- Jitujuri, PS- Manbazar, Dist- Purulia along with following seized articles viz-

1. Mcdwel no 1 rum 180 ML. X 46 bottle = 8280 ML
2. Mcdwel no 1 rum 375 ML. X 06 bottle = 2250 ML
3. Mcdwel no 1 Luxury whisky 180ML X 07= 1260 ML
4. Blue Fighter Whisky 375ML X 05 bottle = 1875 ML
5. Bear Corbberg premium 650ML X 15 bottle = 9750 ML
6. Bear Kingfisher Strong 650 ML X 23 bottle = 14950 ML

I S.I. Soumen Kr. Panda of Manbazar PS do here by lodged a complaint against accused namely Manik Bairagi (47) S/O Lt- Raju Bairagi of village- Jitujuri, PS- Manbazar, Dist- Purulia to the effect that today (23.09.2023) at 17:35 hrs. I received a telephonic information from a reliable source that one Manik Bairagi (47) S/O Lt- Raju Bairagi of village- Jitujuri, PS- Manbazar, Dist- Purulia was stocked ID liquor illegally at New line Hotel (Propiter Bhagwat Mahato) at village Jitujuri, PS- Manbazar, Dist- Purulia and selling the same to hike price for his personal gain. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with HG/ 1443 Uttam Kr. Singh and NVE/1060 Rabindranath Mahato both are Manbazar PS rushed to the spot for raid by Govt. vehicle. At about 17:55 hrs myself along with force reached at Jitujuri new line hotel and held raid in the new line hotel (Propiter Bhagwat Mahato) and found that he is selling the foreign liquor at the above noted hotel and Seeing the police party some persons fled away and said Manik Bairagi tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling foreign liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly signed by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Manik Bairagi (47) S/O Lt- Raju Bairagi of village- Jitujuri, PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
