Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sri Ashok Pandey(Present User), S/O-Lt Shyamapada Pandey**, a permanent resident of **Vill & P.O:Netruria, P.S -Neturia, Dist- Purulia** has committed theft of Electricity u/s **135(i)(b)** of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **19.09.2023** at about **01:00PM** I, Dhritiman Sardar S/O- Rupal Sardar, aged about 25 years, AE & SM Saltore CCC, along with Sri Souvik Mudi, J.E. (Gr-II) and Satya Rajwar, Sr. TSH both attached to Saltore CCC and others had been to the village Neturia for routine disconnection premises visit. During inspection it was found that **Sri Ashok Pandey(Present User)** was consuming electricity dishonestly and unauthorisedly by way of reconnecting the disconnected service connection against consumer ID: 242033380 (Disc. Date 09.11.2019) in the name of Lt Shyamapada Pandey and also bypassing the energy meter at incoming phase terminal with the help of loop connection by a yellow coloured single core cable in his domestic premises having GPS co-ordinates 23.663814,86.825894, for his wrongful gain which resulted causing loss of revenue of WBSEDCL to the tune of load **1.00KVA**. Prior inspection one notice was served upon Sri Ashok Pandey duly received by him.

As theft of electricity was detected during inspection the service cable was disconnected from the nearby electrical source and one bulb with holder had been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list but the accused person denied by putting his signature in the Seizure List, Inspection Report and label. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representatives but the accused person refrain to sign the same. The modus of operandi was photographed and attached. The Unauthorized service connection was disconnected from pole side, after completion of inspection, the inspection team left the aforesaid premises at about **01:25PM**.

Thus the accused **Sri Ashok Pandey(Present User), S/O-Lt Shyamapada Pandey Vill & P.O: Netruria, P.S -Neturia, Dist- Purulia** have committed an offence **u/s 135(i)(b)** of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.

The F.I.R is typed by me. As I was badly engaged in other works so delay was caused to lodge this complaint.
