Sub: Complain to start a specific case.

Sir,

In producing herewith two arrested accused persons namely (1) Riyaj Khan (32 Yrs) S/O- Lt. Nanne Khan of Dishergarh Colony More, PS-Kulti, Dist-Paschim Burdwan (Driver) (2) Monesh Tantubai (52 yrs) S/O- Lt. Baghambar Tantubai of Vill-Gopalpur, PS-Neturia, Dist-Purulia (Helper) along with one seized Auto having registration No- JH 10D/5861 loaded with 1 MT (Approx) coal seems to be steam, do hereby lodge a complaint to the effect that on 23.09.23, I, ASI Sitaram Mandi, along with C/753 Shyam Sundar Mahato, C/1319 Soumen Koley and NVF/0068 Mahanta Mahato all are of Neturia PS were engaged in anticrime day mobile duty vide Neturia PS GDE No- 1035 Dt. 23.09.2023 & CC No- 3226/23 Dt. 23.09.23. In course of Mobile Duty, at about 08:35 hrs when we reached near Sarbari, I received a credible source information to the effect that one Auto having registration No- JH 10D/5861 loaded with illegal coal coming from Barakar side and will transport the same to Raghunathpur side in clandestine manner. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started to move towards Dishergarh Ghat Naka checking Post and started Naka there. In the mean time at about 09:15 hrs found that the above noted vehicle was coming from Barakar side. We indicated the vehicle to stop and on checking it was found that coal seems to be steam was loaded inside the Auto. Then I requested the driver and helper to produce relevant documents/challan/cash memo in respect of loaded coal but they failed to produce any valid documents in support of loaded coal as well as vehicle. On preliminary enquiry it could be learnt that they along with registered owner of seized Auto having registration No- JH 10D/5861 procured the said coal from different illegal coal mines at different area of Barakar side, Paschim Burdwan.

So, it is reasonable to believe that the above noted accused driver, helper and registered owner of the said vehicle have obtained the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen.

Accordingly, I seized Auto having registration No- JH 10D/5861 loaded with raw coal of 1 MT (Approx) under proper seizure list duly signed by available witnesses and also I arrested (1) Riyaj Khan (32 Yrs) S/O- Lt. Nanne Khan of Dishergarh Colony More, PS-Kulti, Dist-Paschim Burdwan (Driver) (2) Monesh Tantubai (52 yrs) S/O- Lt. Baghambar Tantubai of Vill-Gopalpur, PS-Neturia, Dist-Purulia (Helper) in this case. In course of arrest I notified them ground of arrest, issued arrest memo U/S-50 Cr PC and brought them to PS with loaded Auto. I have also sealed & labelled approx 05 (Five) kg coal as sample from the major contraband on the spot. *

Under the above circumstances a specific case may kindly be started against (1) Riyaj Khan (32 Yrs) S/O- Lt. Nanne Khan of Dishergarh Colony More, PS-Kulti, Dist-Paschim Burdwan (Driver) (2) Monesh Tantubai (52 yrs) S/O- Lt. Baghambar Tantubai of Vill-Gopalpur, PS-Neturia, Dist-Purulia (Helper) and (3) Registered owner of seized Auto having registration No- JH 10D/5861 under proper section of law.
