Sub:- Complain for starting a specific case.

Sir,

In producing herewith the seized Tractor along with trolley having registration No. WB 81/0046 (Make- Mahindra B275 DI) loaded with sand approx 100 Cft under proper seizure list. I beg to submit that I, ASI Rajkumar Goswami along with C/159 Dinesh Sardar, C/1302 Radhagobinda Dhibar and NVF/660 Ranjit Kumbhakar were performing anticrime day mobile duty vide Neturia PS GD No- 1176 Dt. 26.09.23 & CC No- 3253/23 Dt. 26.09.23 at PS area and on 26.09.2023 at about 12:25 hrs received a credible source information that one tractor loaded with illegal sand in trolley coming from Benipur side towards Sarbari side. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately moved towards Benipur village side and at about 12:45 hrs reached at Benipur village More and found that above noted tractor was coming from Benipur village side and suddenly the driver stopped the tractor there and after seeing the police party, he got down from the tractor and started to run towards the village area. We chased to apprehend the driver but in spite of hot chase he managed to flee away. Then we searched the tractor and found that the vehicle (tractor) having registration No. WB 81/0046 (Make- Mahindra B275 DI) loaded with sand in Trolley approx 100 Cft.

So, there is reason to believe that the driver and registered owner of the tractor have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Sarbari side knowing it to be stolen.

Accordingly, I seized the tractor along with trolley having registration No. WB 81/0046 (Make- Mahindra B275 DI) loaded with sand approx 100 C.Ft. at 13:25 hrs under proper seizure list duly signed by witnesses. So, the driver and registered owner of the tractor have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver and registered owner of tractor having registration No. WB 81/0046 (Make- Mahindra B275 DI) U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
