Sub: Complain to start a specific case.

Sir.

In producing herewith one arrested accused person namely Rabi Kumar Shaw (32 yrs) S/O- Bijay Shaw of Sitalpur 3 No. Colliery, PS-Kulti, Dist-Paschim Burdwan along with one seized Ashok Leyland vehicle bearing registration No- WB 37D/5574 loaded with 2 MT (Approx) raw coal, do hereby lodge a complaint to the effect that on 08.09.23, I, ASI Rajkumar Goswami, along with C/680 Biswanath Roy, C/1550 Bharat Ghosh and C/1228 Babulal Hansda all are of Neturia PS were engaged in evening mobile duty vide Neturia PS GDE No-385 Dt. 08.09.2023 & CC No- 3086/23 Dt. 08.09.23. In course of evening mobile duty reached at Dishergarh Ghat on Purulia –Barakar pitch road and started Naka checking there. In the mean time at about 20:45 hrs found that the above noted vehicle was coming from Barakar side towards Purulia side under Neturia PS. We indicated the vehicle to stop and on checking it was found that coal seems to be raw was loaded inside the vehicle. Then I requested the driver to produce relevant documents/challan/cash memo in respect of loaded coal but he failed to produce any valid documents in support of loaded coal as well as vehicle and also his driving license. On preliminary enquiry and as per statement of the restrained driver it could be learnt that he along with registered owner have procured said coal from different illegal coal mines at different area under Kulti PS, Dist-Paschim Burdwan.

So, it is reasonable to believe that the above noted accused driver and registered owner of the said vehicle have obtained the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy. They were trying to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen.

Accordingly, I seized Ashok Leyland vehicle bearing registration No- WB 37D/5574 loaded with raw coal of 2 MT (Approx) under proper seizure list duly signed by available witnesses and also I arrested Rabi Kumar Shaw (32 yrs) S/O- Bijay Shaw of Sitalpur 3 No. Colliery, PS-Kulti, Dist-Paschim Burdwan (Driver) in this case. In course of arrest I notified him ground of arrest, issued arrest memo U/S-50 Cr PC and brought him to PS with loaded Ashok Leyland vehicle. I have also sealed & labelled approx 05 (Five) kg coal as sample from the major contraband on the spot.

Under the above circumstances a specific case may kindly be started against Rabi Kumar Shaw (32 yrs) S/O- Bijay Shaw of Sitalpur 3 No. Colliery, PS-Kulti, Dist-Paschim Burdwan (Driver of the seized vehicle No- WB 37D/5574) and registered owner of seized vehicle No- WB 37D/5574 under proper section of law.
