In producing herewith 04 (Four) arrested accd. persons namely 1. Piyush Shaw (20 yrs) S/O Binod Shaw, 2) Nripesh Ball( 20yrs) S/O- Naresh Ch Ball , 3) Bidyut Sarkar (19 yrs) S/O-Ratan Sarkar, 4) Ananda Ball(19 yrs) S/O- Rupesh Ball all of Parbelia Bazar, PS-Neturia, Dist-Purulia and brought under seizure Four motor cycle i)Pulsar NS 160 having no- WB82D/0555, ii) TVS Sport having no- WB82D/7930, iii) Hero Honda Passion Plus having no- WB38T/0172, iv) Pulsar NS 125 having no- WB82E/4793 do here by lodged this complaint against above noted 04 (Four) arrested accd. persons to the effect that today i.e. on 11/09/2023 at 21:15 hrs. Myself alongwith C/1319 Soumen Koley, C/753 Shyamsundar Mahato, C/1302 Radhagobinda Dhibar were performing NAKA checking duty on Purulia- Barakar Pitch Road (SH-5) near Maa Mansa Petrol Pump under Neturia PS vide CC no- 3111/23 dtd- 11/09/23. We found that four motor cycle rider without helmet were coming from Barakar side. We stop them and asked them to produce valid papers and why they are riding motor cycle without helmet. But they started arguing with us. We try to convince them that we are discharging Govt duty and if they failed to produce any papers, we have no option but to submit prosecution. But they did not pay any heed and arguing with us. When I try to submit prosecution as per provision of MV Act, they become more violent and started assaulting to police team. As a result, Myself alongwith C/1319 Soumen Koley, C/753 Shyamsundar Mahato sustained bleeding injuries and shifted to Harmadih CHC. They assaulted police personnel to deter us from discharged of Govt duty. Under this circumstances, Myself alongwith help of other forces arrested 04 (four) accd persons namely 1. Piyush Shaw (20 yrs) S/O Binod Shaw, 2) Nripesh Ball( 20yrs) S/O- Naresh Ch Ball , 3) Bidyut Sarkar (19yrs) S/O-Ratan Sarkar, 4) Ananda Ball(19 yrs) S/O- Rupesh Ball all of Parbelia Bazar, PS-Neturia, Dist-Purulia in between 21.45 hrs to 22.15 hrs after maintain all formalities regarding arrest and seized Four motor cycle i)Pulsar NS 160 having no- WB82D/0555, ii) TVS Sport having no- WB82D/7930, iii) Hero Honda Passion Plus having no- WB38T/0172, iv) Pulsar NS 125 having no- WB82E/4793 from the PO and from the possession of arrested accd. persons in between 22.25 hrs to 22.45 hrs after preparing proper seizure list duly signed by witnesses.

Therefore, I do hereby lodged this complaint against above noted accd. persons to start a specific case U/S- 341/186/353/332/333/337/338/34 IPC.
