Sir,

In producing herewith the arrested one accused person namely 1) Biplab Mallick (29 Yrs) S/o Bimal Mallick of Vill+PO-Kholta, PS-Kundibari, Dist-Cooch Behar, 2) Jiten Choudhury@Pasi (30Yrs) S/o Lt. Laxman Choudhury of Vill-Chokbad, Ambagan, PS-Santaldih, Dist-Purulia, and 3) Sunil Aghari (35 Yrs) S/o Lt. Chaitu Aghori of Vill-Kanki Bazar, near Karbala Maidan, PS-Santaldih, Dist-Purulia with seized articles as per seizure list.

I, SI Kazi Kawsar Nafis of Para PS beg to report that on 06.09.23 myself along with force viz, C/351 Kanailal Bauri, C/3010 Kanchan Majhi and C/2948 Ardhandu Mandal were performing evening patrolling duty at Darda-Bhara side area vide Para PS GDE No- 215 and CC No- 3066/23 dated 06.09.2023 with Govt. vehicle. At 22.20 hrs received a credible source information that 5/6 persons being armed with deadly weapons assembled in an open place by the bank of the Harai River near Darda village under Para PS with a view to commit dacoity. The information was communicated to O/C Para P.S and as per his direction in order to work out the information myself along with force who were with me left for the place where they were assembled. We reached near the spot, approx ½ km away from the actual place, around 22.28 hrs. Keeping the vehicle in a safe distance, we started on foot and slowly arrived near the spot and heard some whispering of some persons. We the Police party without wasting a single moment tried to encircle them from behind. With the help of the focus of the torch light we noticed that 5/6 persons being armed with deadly weapons like iron rod, Knife, lathi were assembled in an open place by the bank of the Harai River near Darda village. Seeing the Police party all of them started to escape but after a hot chase the above noted accd. persons could be apprehended.

On primary interrogation the apprehended accused person stated their name and address as noted above and confessed that they were assembled there for committing dacoity in Darda village. Before entering into the search of their person, tried to find out some local independent witnesses but as the place is an isolated one none could be available.

During search of the said accd persons 1) One iron made "BHOJALI" measuring 08 inch approx and one plastic Torch was recovered from the possession of accused Biplab Mallick (29 Yrs) S/o Bimal Mallick of Vill+PO-Kholta, PS-Kundibari, Dist-Cooch Behar and 2) One iron rod length 06 feet approx and one Iron made knife was recovered from the possession of accused Jiten Choudhury@Pasi (30Yrs) S/o Lt. Laxman Choudhury of Vill-Chokbad, Ambagan, PS-Santaldih, Dist-Purulia and 3) one iron rod having sharp cutting edge along with nylon rope was recovered from the accused Sunil Aghari (35 Yrs) S/o Lt. Chaitu Aghori of Vill-Kanki Bazar, near Karbala Maidan, PS-Santaldih, Dist-Purulia. So there is sufficient reasonable ground to believe that they were assembled there at that odd hours with deadly weapons with a view to commit dacoity. So, I arrested them, informing them of the ground of their arrest and seized the above articles under proper seizure list duly signed by witnesses and accd persons observing all formalities and procedures of law. The seizure was made between 22.45. hrs to 23.10 hrs. on 06.09.2023.

Therefore I pray that a specific case may kindly be started against the above noted accd. persons and arrange for its investigation.
