Subject-Request for through investigation and legal action regarding an assault on LT staff under Pancha CCC

Dear Sir,

I am writing to bring a serious incident to bring your attention that occurred yesterday 3rd September 2023 at near about 7.30P.M in Bhagabandh Village under your jurisdiction. This incident involve an assault on one of my LT mobile van staff namely Mr. Bikash Chandra Mahato, S/O- Prabhakar Mahato, Vill+P.O-Tatari, P.S-Pancha, Dist-Purulia.

On the aforementioned date and time, my staff was dispatched to Bhagabandh village for the purpose of addressing a docket concerning the issue of no electricity in that area. Regrettably upon their arrival, a group of individuals from that village forcibly blocked their car, leading to an altercation that escalated tragically. One of these individual identified as Gauranga Patra, S/O-Nakul Patra, Vill+P.O-Bhagabandh, P.S-Pancha, Dist-Purulia physically assaulted and slapped my LT supervisor, Bikash Chandra Mahato, S/O-Prabhakar Mahato in violent manner.

Witnesses at the scene have been informed me that Bikash Chandra Mahato lost his consciousness immediately following the attack and he was admitted to hospital immediately and regained consciousness after initial medical attention. Upon regaining consciousness Bikash Chandra Mahato conveyed me that he was left in a state of extreme fear and emotional distress due to the said traumatic incident he endured.

I kindly request you to initiate an investigation and bring those are involved, particularly Gauranga Patra, S/O-Nakul Patra of Vill-Bhagabandh, P.S-Pancha, Dist-Purulia and take proper action as per law so that in future such incident shall not be repeat.

The complaint could not be registered earlier, as the undersigned was busy in power restoration work.
