Dear Sir,

Greetings of the day!

We have a fly ash bricks & block manufacturing SSI unit situated at **Barakar Road, PO & Vill Kustaur, PS Purulia (M), Purulia – 723126.**

We would like to bring into your notice that on **01/09/2023** midnight at **1:38 AM** some unknown miscreant(s) with their face covered entered our factory premises and carried out the entire theft operation as mentioned below:-

- 1) At 1:38 AM some unknown miscreant(s) entered the factory by cutting the barbed wire of South Side Factory wall and broke the camera which was focused on that point of entry.
- 2) They managed to get inside the Shed by breaking the lock of Shed's gate and entered the store room at around 1:55 am.
- 3) After breaking into the store room at 2:02 am, they started to carry away all iron made costly spare parts of machines and this continued till 2:25 am.
- 4) At around 2:25 am when the guards flashed their torch lights they managed to escape without getting noticed by the guards.

We being a very small SSI unit of your land are very much in fear and tensed that how shall we be able to manage these huge losses which are happening due to such event. This kinds of event bring fear sycosis in us and our workers.


We ask for your shelter, mercy and guidance on how such event can be avoided in future under your supervision. Please give us Shelter.
