Sir,

In producing herewith one arrested accused person namely Falguni Mahato (49 Yrs) S/o- Lt. Khagendra Nath Mahato of Vill- Belma, PS- Purulia (M), Dist- Purulia along with seizure list and seized articles.

I beg to state that today (14.09.2023) evening while I along with force (i) C/2735 Soumen Nayek (ii) C/321 Tulsidas Roy (iii) C/497 Ambuj Kr. Mandal all of Purulia (M) PS vide GDE No- 702 & C.C No- 3642/2023 Dtd. 14.09.2023. During my anti crime mobile duty, at about 14.45 hrs I received a secret tip off that an illegal possession of a huge quantity of liquors. Subsequently, I informed you and as per your direction, I rushed to the spot at Dumurdih morh at Tata Hotel and after arriving at the spot and as per your instruction conducted raid in the said Hotel of Falguni Mahato under this PS at about 15.15 hrs. During the raid some people fied away and detained one person. On being asked he disclosed his identity as Falguni Mahato (49 Yrs) S/o- Lt. Khagendra Nath Mahato of Vill- Belma, PS- Purulia (M), Dist- Purulia. On interrogation he confessed that he procured and stocks the liquors for seiling illegally from his HOTEL. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors from his. HOTEL. Subsequently, I seized (i) 24 (Twenty Four) sealed bottles country spirit (DIL KHUSH) each containing 600 ml. In which 01 sealed bottles was taken as samples. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 15.25 & 15.40 hrs.

Accordingly, I arrested the above noted accused person at 15.45 hrs after maintaining all formalities regarding arrest. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray you kindly take lawful action against the arrested accused person namely Falguni Mahato (49 Yrs) S/o- Lt. Khagendra Nath Mahato of Vill- Belma, PS- Purulia (M), Dist- Purulia under proper section of Law.
