Subject: Complaint of Physical Assault.

Respected Sir,

I, Ratish Thakur⁽⁴⁵⁾ (GM Tech.), S/o-Mahesh Thakur, M/S Varaha Infra Ltd, NH-32 Purulia Bypass road project, Near Belkuri Toll Plaza, PS-Purulia (M), Dist-Purulia writing to formally report a recent incident of physical assault that I experienced today 17.09.2023 @ 10:30 A.M. I am deeply concerned about this incident and seek your assistance in pursuing the appropriate legal actions.

On the aforementioned date, I was during site visiting at Baghudih village, under Purulia (M) PS, Dist-Purulia 04 (four) ladies namely (i) Joytsna Rajwar (ii) Mirtika Rajwar (iii) Taramoni Rajwar (iv) Sanaka Rajwar all of D/o- Kalebar Rajwar all of vill- Baghudih, PS-Purulia (M), Dist-Purulia leading up to the attack, on my car throwing stone and batting with bamboo and steel rod myself and my driver and Supervisor. During this incident, I was physically assaulted. I believe that this assault was unprovoked and unjustified. I shouting please any person to rescue me then the aforesaid accused persons fled away after snatching some cash of Rs. 5600/- (500 x 11+100 x 01 = 5600/)

I immediately sought medical attention following the attack, and I have attached the relevant medical records and photographs of my injuries as evidence. Additionally, I have included the contact information of any witnesses who can provide further details about the incident.

I understand the importance of a thorough investigation, and I am willing to cooperate fully with any inquiries regarding this matter. I kindly request that an investigation be initiated regarding this incident, and I hope that the responsible party will be held accountable for their actions.

Please provide me with a case number or reference number for this complaint, as well as information on how I can follow up on the progress of the investigation.
