Most respectfully begs to state:-

1. That the land fully described herein below belongs to Gour Sinha @ Gour Chandra Sinha, after his death in the year 1945 or like so said Gour Sinha died leaving behind his widow Sushilabala Sinha and Kalyani Sinha.
2. Said Kalyani Sinha was married with Hirendranath Ghosh.
3. That said Gour Sinha died leaving behind 56 decimal the value of which is more than Crore and Crore Rupees of land and after demise of Gour Sinha said land inherited by Sushilabala Sinha, who in her term, sold the land to Hirendranath Ghosh who married Kalyani Sinha, the only daughter of Gour Sinha and Sushilabala Sinha.
4. That after the death of Hirendranath Ghosh, Kalyani Ghosh, the widow, Bikash Kumar Ghosh and Alope Kumar Ghosh and two daughters namely Jyotsna and Kalpana inherited the property of 56 decimal of land left by Hirendranath Ghosh.
5. That in view of Hindu law, before the death of 2000 the daughters have only residential right so, the 56 decimal of land will be divided in 3 equal share i.e. 18.65 decimal (approx) of land to each share holders i.e. in favour of Kalyani Ghosh, Bikash Kumar Ghosh and Alope Kumar Ghosh.
6. That if the share of Jyotshna & Kalpana is calculated than the share should be 11.2 decimal each.
7. That Ashok Kumar Sarkar and Sanket Sinha, the above named two accused person, by manufactured a false deed, in order to grab the land of Hirendranath Ghosh, prepared a purchase deed in the year 1988, shown therein that 53 decimal of land has been purchase from said Kalyani Ghosh and long after 35 years, i.e. after the death of Kalyani Ghosh made an attempt/applied for correction of record of right being J.L. No.-05, R.S. Khatian No.-558, L.R. Khatian No.-1614 Plot No.-2028, area 56 decimal.(56 Decimal)
8. That the complainant Alope Kumar Ghosh, protested the same and mentioned therein that Hirendranath Ghosh died on 04/07/1977 i.e. long before the purchase from Kalyani Ghosh.
9. That when no action was taken from the appropriate authority he obtained on expert report from his source and found that the signature and L.T.I. made in the deed by Kalyani Ghosh in the year 1988 is /are manufactured one.
10. That your petitioner complainant/ gave letter to Inspector-in-Charge, Purulia(M) P.S., Superintendent of Police, Purulia, B.L. & L.R.O., and prayed therein for necessary action against the wrongdoer but of no good.
11. That the B.L. & L.R.O. Office told to come through Ld. Court/P.S. because two of the friends of Ashok Kumar Sarkar and Sanket Sinha who are employee at S.D. & L.R.O. Office under D.L. & L.R.O. Office, there are helping Sri Ashoke Kumar Sarkar & Sanket Sinha so the complainant will get no fruitful result.

12. That the expert report in Xerox as well as an opinion given by Amlan Sarkar the forensic expert, is enclosed herewith for your kind perusal and ready reference.
13. That now a days some persons/wrongdoers in collusion with others in order to grab the lands, manufactured sale deed and praying for rectification of R.O.R. record, long after 30-32 years or after the death of executant / donor so that the matter can be hush-up by making fraud and cheating.



That as the matter required thorough investigation and ex-pert opinion and other technical force are there, so this petition is required to be send to the I/C, Purulia(M) P.S., u/s-156(3) of the Cr. P.C. to treat the same as an FIR and to book the wrongdoer under the provision of I.P.C.
