Sub: Prayer for lodging FIR.

Sir,

With due respect I beg to state that; today (25.09.2023) while myself along with force (i) C/- 497 Ambuj Kr. Mandal & (ii) HG- 1576 Sháktipada Mahato both of Purulia (M) PS, Dist- Purulia were engaged in Day Mobile duty vide Purulia (M) PS C.C No- 3764/2023 Dtd. 25.05.2023 and PS GDE No-1291 Dtd. 25.09.2023, at about 14.05 hrs I receive an information from my source regarding a huge quantity of illegal stock of coal near Buridih village under Purulia (M) PS. Accordingly, I informed the matter to you and as per your guidance and instruction I along with force had been to the said place at about 15.15 hrs. After that as shown by the source we are reached that place i.e. Mouza- Buridih, J.L No- 23, near Madhupur Ashram School beside one Brick Bhata (GPS location of the site is 23.395784, 86.284732) and found that a huge quantity of coal is stocking there. But nobody was present there to claim the same coal, except Police personnel. I searched the surrounding area to trace out the owner of said coal, but nobody was found to its ownership.

Made an local enquiry and it is found that (i) Bikash Gorai @ Lelha S/o- Lalu Gorai @ Umapada & (ii) Amrit Gorai S/o- Rajaram Gorai both of Vill- Shibdih, PS-Purulia (M), Dist- Purulia stocked the said coal at the above maintained place for selling the same to make their own profit by dishonestly and they have been running a clandestine business. On preliminary enquiry it could be learnt that they procured the said illegal coal from different places and transported the same in a clandestine manner to another district/state. So, it is reasonable to believe that they were transporting the coal illegally after procuring. Accordingly finding no other alternative way I seized approx 08 (Eight) Ton of steam coal under proper seizure list duly signed by the accompanied Police persons as there was no availability of any local person, as such I could not collect the signature of the local people in all seizure list and during seizure I had taken 02 Kg coal from the stoking coal. The seizure was done in between 14.35 & 16.25 hrs. After that we made a proper arrangement to bring the coal at PS to keep in PS compound.

Therefore, I pray before you that a specific case may kindly be registered under proper section of law against (i) Bikash Gorai @ Lelha S/o- Lalu Gorai @ Umapada & (ii) Amrit Gorai S/o- Rajaram Gorai both of Vill- Shibdih, PS- Purulia (M), Dist- Purulia and the owner of said land for illegal stocking of coal at above mentioned place.
