Sir,

In producing herewith one arrested accused Driver namely Jadu Rajak (23 Yrs) S/o- Dhulu Rajak of Vill- Kalikapur, PO- Kanakchas, PS- Chandankayari, Dist- Bokaro, Jharkhand and brought under seizure one vehicle (TATA 3118c) having Reg. No- JH 09AC 1313 and I, SI Subrata Sarkar of Purulia (M) PS do hereby lodged this complaint against the Driver of said vehicle.

I beg to state that today (20.09.2023) while performing Naka Checking duty at Bhangra Battol under Purulia (M) PS (This refers to Purulia (M) PS GDE No- 1030 Dtd. 20.09.2023) along with force (i) C/- 241 Sumit Chakraborty & (ii) C/- 178 Tulshi Mahato both of Purulia (M) PS. At 14.45 hrs, I received telephonic information that one vehicle (TATA 3118c) having Reg. No- JH 09AC 1313 dashed one Sk Koka s/o Seikh Azad of Vill- Joynagar, PS- Purulia (M), Dist- Purulia while he was beside Joynagar bazaar by the rash and negligent driving of the driver of the vehicle. As a result he received injuries in his person. I informed the matter to I.C Purulia (M) PS and make an arrangement to intercept the vehicle at Bhangra Battol after following all SOPs of NAKA.

During NAKA checking at Bhangra Battol at about 14.55 hrs I tried to detain the vehicle coming from Joynagar side, the said driver of the vehicle also managed to escape by break through or NAKA as well as guardrails rashly. He was driving recklessly at more accident prone area in Purulia town and Purulia (M) PS area; there is every possibility of loss/serious injury of nearby public due to his rash and negligent driving. After a hot chase at 15:55 hrs, we managed to stop this vehicle at bye pass near Chas morh under Purulia (M) PS. It is also note down here that while the vehicle was fleeing recklessly and at high speedon that time the said vehicle also dashed some guardrails which were lying beside the pitch road. As a result some guardrails also damaged by said vehicle during this incident at Bhangra Battol, University morh and Imundi morh under Purulia (M) PS and also in Purulia Town PS area.

Subsequently, I intercepted the said vehicle (TATA 3118c) having Reg. No- JH 09AC 1313. On being interrogated the driver of the vehicle disclosed his identity as mentioned above but was unable to give any satisfactory answer for his type of negligent driving which may endanger for human life. As the driver of the vehicle having control could not give satisfactory reason for his rash and negligent driving which could be taken into consideration as dangerous driving. Accordingly, I arrested the driver namely Jadu Rajak (23 Yrs) S/o- Dhulu Rajak of Vill- Kalikapur, PO- Kanakchas, PS- Chandankayari, Dist- Bokaro, Jharkhand after maintaining all the formalities as well as guidelines of Hon'ble Supreme Court and NHRC regarding arrest after issuing Check List. I informed him of the grounds of arrest and his family members. The arrest was made at 16.10 Hrs, I asked him to produce valid documents in respect of said vehicle but he failed. After that I seized the said vehicle (TATA 3118c) having Reg. No- JH 09AC 1313 under proper seizure list duly signed by the witnesses. The seizure was made in between 16.15 and 16.25 Hrs.

Under the above fact and circumstance, I therefore pray before you to start a specific case against the driver of the vehicle (TATA 3118c) having Reg. No- JH 09AC 1313 namely Jadu Rajak (23 Yrs) S/o- Dhulu Rajak of Vill- Kalikapur, PO- Kanakchas, PS- Chandankayari, Dist- Bokaro, Jharkhand under proper section of Law.
