Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Umakanta Mahato (25 Yrs) S/o- Labkishore Mahato of Vill- Golbera, PS- Purulia (M), Dist- Purulia and seized articles (i) 14 (Fourteen) sealed bottles of 'CAPTAIN' & (ii) 07 (Seven) sealed bottles of 'DIL KHUSH' along with seizure list, Memo of Arrest.

I beg to state that today (27.09.2023) evening while I along with force (i) C/- 2409 Binayak Dubey (ii) C/- 699 Biswajit Banerjee all of Purulia (M) PS vide GDE No- 1472 Dtd. 27.09.2023 were performing Day mobile duty. During my Day mobile duty, at about 15.05 hrs I received a secret tip off that an illegal possession of a huge quantity of liquors. Subsequently, I informed the matter to you and as per your direction, I rushed to the spot at the Gumti Shop situated near Chas morh on the side of Purulia to Ranchi pitch road (Opposite side of the Dulal Mahato Line Hotel) under Purulia (M) PS and after arriving at the spot and as per your instruction conducted raid in the said Gumti at about 15.45 hrs. During the raid some people fled away and detained one person. On being asked he disclosed his identity as Umakanta Mahato (25 Yrs) S/o- Labkishore Mahato of Vill- Golbera, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he stocks the liquors for selling illegally in his Gumti. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors from his Gumti. Subsequently, I seized (i) 14 (Fourteen) sealed bottles of 'CAPTAIN' & (ii) 07 (Seven) sealed bottles of 'DIL KHUSH', containing 600 ml each. In which 02 sealed bottles were taken as samples from each item. I seized the same under proper seizure list in presence of witnesses, duly signed by the witnesses and accused person. The seizure was made between 15.55 & 16.20 hrs. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.


Accordingly, I arrested the involved accused person namely Umakanta Mahato (25 Yrs) S/o- Labkishore Mahato of Vill- Golbera, PS- Purulia (M), Dist- Purulia at 16.25 hrs after maintaining all formalities regarding arrest and NHRC guidelines, issued Memo of Arrest. Informed him regarding the ground of arrest and also informed his family members.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Umakanta Mahato (25 Yrs) S/o- Labkishore Mahato of Vill- Golbera, PS- Purulia (M), Dist- Purulia under proper section of Law.
