I Sri Prashant Kishor, S/O - Kishori Prasad, Station Manager of Telkalpara CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Ashutosh Das S/O Haradhan Das of Vill - Bhabanipur PS- Purulia (M) has committed theft of electricity under section 135(1)(A) as detailed here under.

Today, i.e. on 27.09.2023 I, Prashant Kishor (SM), along with Sri Suraj Kumbhakar JE (GR-II), & Sri Deb dulal Banerjee Sr TSH of Telkalpara CCC, WBSEDCL conducted a raid programme at village Bhabanipur under Purulia (M) P.S. When our team at about 02.00 p.m.. entered to the Domestic premises of Ashutosh Das, we found that he was enjoying electricity dishonestly by means of direct hooking from nearest Distrubution Box of L.T.O.H.A.B. Cable and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized, and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 02.30 p.m.. after completion of inspection & necessary formalities.

Ashutosh Das S/O Haradhan Das of Vill - Bhabanipur, PS- Purulia (M) has committed theft of electricity under section 135(1)(A) of the Electricity(Amendment) Act-2007.


