
F. Place of Occurrence:

The above name complainant begs to state as follows:-

- 1) That your complainant is a permanent resident of Dulmi Nadiha Chatani Para, P.O. Dulmi Nadiha, P.S. Purulia (Town), District-Purulia and within the jurisdiction of this Ld. Court.
- 2) That your complainant got married with accd No 1 on dated 29.12.2012 at District Registarar & Ex-Officio Special Marriage Officeer Purulia, P. O. Purulia, P.S. Purulia (T), Dist-Purulia under special marriage Act 1954 and after solemnization of marriage your complainant took accused No 1 at his house at Dulmi Nadiha Chatani Para, P.O. Dulmi Nadiha, P.S. Purulia (Town), District-Purulia and within the jurisdiction of this Learned Court and started to live there as husband and wife.





- 3) That at the time of marriage and prior to marriage at the time of negotiation the father in law since deceased, mother in law accused no. 2 & accused no.1 presented and pretends accused no.1 as unmarried before your complaint and his familiar circle and being convinced over the words of accused no. 1 & 2 your complainant agreed to marry accused no. 1.
- 4) That thereafter the marriage between the accused no. 1 and your complainant held / performed on dated 29/02/2012 at the office of Ex-Officio Special Marriage Officer Purulia, P. O. Purulia, P.S. Purulia (T), Dist-Purulia under special marriage Act 1954 where in the form of intending marriage in column of "condition" which was filled up during the course of marriage accused no. 1 stated and declared herself as unmarried. Thus the accused no. 1 & 2 cheated deliberately to your petitioner and broke his trust after taking him and his family members and circle in confidence. The petitioner in good faith performed whatever required at the time for registration of marriage.
- 5) That be it mentioned here Vivekananda Roy, S/O Late Debendra Roy, Resident of Vidyasagarpally, P.O.- Purulia P.S.- Purulia (T), Dist. Purulia & Sudip Mukherjee S/o Shyamaprasad Mukherjee, Resident of Ward no. 13, within Purulia Municipality, P.O.- Purulia, Dist. Purulia, were the witnesses cum identified cum introducer on behalf of the accused no. 1 and they also confirmed the matrimonial status of accused no. 1 as unmarried and thus accused no. 3 & 4 were the part of the conspiracy of accused no. 1 & 2.
- 6) That later all of a sudden your complainant on dated 18/07/2023 came to know that he and office of Ex-Officio Special Marriage Officer Purulia, P. O. Purulia, P.S. Purulia (T), Dist-Purulia, has been cheated by accused persons in a pre-planed way with common intention.
- 7) That thus knowingly in a pre-planed way accused no. 1 with the help of the others accused persons cheated your complainant by way of

presenting herself as unmarried although she was a divorcee at the time of registration of marriage.

8) That your complainant reported the incident to the Purulia (Town) P.S. and Superintendent of Police of Purulia but till today not any action has been taken by the police against the accd. persons so your complaint took shelter before this Ld. Court.

9) That your petitioner is a poor man and is not in position to pull the burden of complain case, so a police case is desirable.

10) That the accd. persons have committed the offence U-/S-420/406/199

/ 506/341.P.C.1.P.C. and they are liable to be punished accordingly.

It is therefore prayed that your Honour may graciously be pleased to accept the petition and further be pleased to direct the O.C./Inspector-in-charge of Purulia (Town) P.S. treating the same as F.I.R. U / S - 156(3) Cr.P.C. and to investigate the matter and started a specific case against the accused persons.
