**Subject: - FIR against Anindita Gorain, Wife of Niranjan Gorain, resident of Rathtala ,Purulia(T) thana , Dist Purulia .**

Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 (1)/(b) & (1)/(d) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 20/09/2023 at 13:40 Hrs. I, Subhajit Pratihar(AE & SM Purulia CCC) along with Biswanath Barui (AE S&LP attached to Purulia Regional Office WBSEDCL) , Promod Ranjan Barman (Special officer attached to Purulia Regional Office, Chinmay Maity (JE Purulia CCC) , Anurag Pandey (OE Purulia CCC) , Sankar Ch Mahato (ACM Purulia Regional Office WBSEDCL) and Dayamay Mahato (Sr TSH Purulia Region Office WBSEDCL) went to make an inspection to workout upon a source information regarding theft of electricity at the domestic premises of user Anindita Gorain, Wife of Niranjan Gorain, resident of Rathtala ,Purulia(T) thana , Dist Purulia .

During the time of inspection at the premises 1 no of electricity meter were found having serial no BB0853786(Consumer id 242084911, Consumer Name- Anindita Gorain).

It was observed that accused Anindita Gorain has made unauthorized use of electricity under section 135 1/b & 1/d by inserting foreign material in meter serial no BB0853786, which works as resistance to interfere with accurate or proper registration of electricity consumption and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using AC 2 nos 1.5KW each, cooler Fan 4 nos (60 watt each) , Light 10 nos (9 watt each) , Pump 1 nos 746 watt , inverter 2 nos 250 watt each , Fridge 2 nos 175 watt each.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected both the service lines in the same premises from pole with the help of LT Mobile Van Team and removed & seized 1 nos of damaged energy meter bearing meter no BB0853786. Prepared seizure list and inspection report. Accused refused to sign the seizure and inspection documents.

The inspection team left the premises at about 14:05 Hrs on 20<sup>th</sup> Sept 2023.

The accused committed theft of electricity U/S 135 (1)/(b) & (1)/(d) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
