**Subject: - FIR against Hafizur Rahaman, Son of Late Hamid Ali Pradhan, resident of Saudagarbandh Para,Purulia(T) thana , Dist Purulia .**

Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 (1)/(a) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 20/09/2023 at 14.15 Hrs. I, Sri Subhajit Pratihar , A.E & Station Manager , Purulia Customer Care Centre (CCC) along with Biswanath Barui (AE S&LP attached to Purulia Regional Office WBSEDCL) , Promod Ranjan Barman (Special officer attached to Purulia Regional Office, Chinmay Maity (JE Purulia CCC) , Anurag Pandey (OE Purulia CCC) , Sankar Ch Mahato (ACM Purulia Regional Office WBSEDCL) and Dayamay Mahato (Sr TSH Purulia Region Office WBSEDCL) went to make an inspection to workout upon a source information regarding theft of electricity in the premise of Hafizur Rahaman, Son of Late Hamid Ali Pradhan, resident of Saudagarbandh Para ,Purulia(T) PS, Dist Purulia .

It was observed that accused Hafizur Rahaman has made unauthorized use of electricity under section 135 (1)/(a) by direct hooking from our nearest LTOH line through a 2 core black color pvc cable, connected to the wiring. From the above arrangement the accused was using 3 fan , 4 light , 1 tv and 1 fridge.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected the hooking arrangement from pole with the help of LT Mobile Van Team and removed & seized the hooking arrangement.

The inspection team left the premises at about 14.31 Hrs on 20<sup>th</sup> September 2023.

The accused committed theft of electricity U/S 135 (1)/(a) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
