Sub: Prayer for lodging F.I.R. against arrested accused person Bhakti Bauri (41 Yrs) S/o Lt. Anil Bauri of Mahulghuta, Ward No-11, PS- Purulia (T), Dist. - Purulia.

In producing herewith one arrested accused person namely person Bhakti Bauri (41 Yrs) S/o Lt. Anil Bauri of Mahulghuta, Ward No-11, PS- Purulia (T), Dist. - Purulia under arrest alongwith following seized articles under proper seizure list and being labeled properly:-

(1) 14 (Fourteen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80° UP and MRP is Rs 55/- being sealed properly) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149.

(2) Out of 14 (Fourteen) bottles 01(one) bottle is kept as sample.

I, PSI Ashoke Mahata, beg to report that while I was performing night RT mobile duty vide Purulia (T) PS GDE No 1539 dated 25.09.2023, at about 22:05 hrs received a secret telephonic information from source that one person namely Bhakti Bauri S/o Lt. Anil Bauri of Mahulghuta, Ward No-11, PS- Purulia (T), Dist. - Purulia is selling country spirit illegally at a higher price to the customers causing unlawful gain at his dwelling house at Mahulghuta.

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting C/295 Badrul Hazari and C/1335 Nirmal Mahata all of Purulia (T) PS proceeded to work out the information.

At 22:15 hrs we reached at Mahulghuta and keeping our Govt. vehicle at a reasonable distance we preceded towards the house of above noted Bhakti Bauri as shown by the source from the distance and found that the said person was selling Country Spirit as noted above to some persons, some persons were found drinking there. Seeing the police, all of them fled away from the spot. On hot chase seller could be nabbed. On interrogation he confessed his guilt as he was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. He also failed to produce any licence in favour of selling, keeping or possessing Country Spirit and the said person disclosed his identity as noted above. On search of the house we found 14 (Fourteen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80° UP) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149. As such in between 22:25 hrs to 22:35 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after labeling and seal properly. I also took samples and arrest him at 22:45 hrs observing all the formalities regarding arrest as the said person committed an offence which attracts sec. 46 A (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
