This is for your kind information, that I am  
resident of Ward No-12, Gasaipara, village - Nandurda PO PS - Raghunathpur  
Pin - 723133 District Purulia West Bengal and I am assistant Professor  
of Medicine department and Faculty member of Medicine of Bankura  
Sammilani Medical College.

Today Mr. Kajal Acharyya, Shyamal Acharyya and their another  
4-relatives (all of them having title Acharyya), names I will give  
you later) attacked my wife Mrs. Nilima Das and daughter  
Himashree Das and me and attacked with bricks and wooden  
bamboo sticks and beat severely and my wife got injured  
in head and eye and bleeding continuously and she is  
not able to see at present and I was beaten physically  
and my daughter was also beaten by them.

Cause of attack is best known to them.  
Please take immediate necessary steps legally and urgently  
and strong legal action against the perpetrators.

Now at present (3:30 PM), my wife is admitted in female  
surgical ward and cut wounds are being stitched at  
female surgical ward at Raghunathpur Multi speciality  
Hospital. This incident of attempt of murder happened at  
around 2:30 PM today.
