Respected sir,

In producing herewith the 01 arrested accused person namely Janardan Bauri (28Y), S/O Pasupati Bauri of Vill. - Amchatar, PS - Santaldih, Dist. - Purulia and one seized vehicle (Mahindra Tractor loaded with sand) without number plate having Engine No.- RENW02161 attached with, trolley with Seizure List. The nub of the fact in a nutshell is that today (14.09.2023) while I, along with C/584 Madhab Majee & C/586 Bholanath Dey, were performing special mobile duty vide Santaldih PS GDE no. 660, dated 14.09.2023, at Santaldih PS area, I, received a tip off at 18:05 hrs, at Santaldih -Paharigora road, near Paharigora under Santaldih PS, some persons were illegally carrying sand by a suspicious tractor. Subsequently, I along with force proceeded towards Santaldih - Paharigora road, Paharigora to work out the tip off. While, I along with force arrived at near Paharigora more under Santaldih PS and found that, some persons are illegally carrying sand into a tractor.

I, along with force proceeded to detain the tractor and reached at the spot i.e. Paharigora more, PS - Santaldih at 18:15 hrs but seeing the police persons the driver tried to flee away with tractor loaded with sand and we apprehended him. On being asked, he disclosed his name and address as Janardan Bauri (28Y), S/O Pasupati Bauri of Vill. - Amchatar, PS - Santaldih, Dist. - Purulia but unable to produce any valid documents in respect of the said tractor as well as loaded sand in it. He also stated that as per consent and involvement of his owner he is running this business by means of illegal transportation of sand for their wrongful gain.

During enquiry, it is ascertain that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business by transporting the same at Jharkhand State. So, it is reason to believe that they in cahoots with the owner of the vehicle procured the said sand from Gowai river bank by fraudulently means or theft by any means for transporting the same at Jharkhand State to run clandestine business. As per source information, they are habitual offender of this crime, as they have been engaged in the said illegal sand leafing business since long, behind the eyes of the administration.

So, I, arrested the above noted accused observing all arresting guidelines. During interrogation he also confessed his guilt in this case. I also seized the above noted tractor along with trolley loaded with sand with proper seizure list duly signed by witnesses. On demand he failed to produce his driving license. Thereafter, I brought the arrested person and the seized tractor along with the loaded sand into the trolley to Santaldih PS.

Under above fact and circumstances, I, pray before you to start a specific case against the above noted driver namely Janardan Bauri (28Y), S/O Pasupati Bauri of Vill. - Amchatar, PS -Santaldih, Dist. - Purulia and the owner of the above noted tractor having Engine No. RENW02161 under proper sections of law.
