In producing herewith 05 arrested accused persons namely (i) Sujit Mahatha (38Y), S/O Lt. Rabi Mahatha, (ii) Ambuj Mahatha (55Y), S/O Lt. Bharat Mahatha, (iii) Radheshyam Gorai (37Y), S/O Dhiren Gorai All of Vill. - Poradih, (iv) Jiten Kumbhakar (43Y), S/O Lt. Santiram Kumbhakar, (v) Manab Kumbhakar (52Y), S/O Lt. Tarapada Kumbhakar both of Vill. - Aguitard, all of PS - Santaldih, Dist. - Purulia, I, SI Shuvankar Sarkar, In-charge, Santaldih I.C. (BCW) under Santaldih PS, beg to state that today (16.09.2023) at about 15.00 hrs in course of performing evening mobile duty vide Santaldih I.C. (BCW) GDE no. 337, dt. 16.09.2023 and C.C. No. 1862/23, dt. 16.09.2023 ASI Rabin Mukherjee along with C/29 Koushik Ghatak & NVF/100 Bhakta Ruhidas have received an information that above noted 1) Sujit Mahatha, 2) Ambuj Mahatha, 3) Jiten Kumbhakar, 4) Radheshyam Gorai and (vi) Bibek Singh and 3/4 others have created obstruction of vehicles at BCW Bus Stand under Santaldih PS. Accordingly he along with force rushed to the spot and found that the above noted persons obstructed the road on demand of its repairing and as a result a good number of vehicles including buses and other passenger vehicles are unable to ply on the road. Due to such obstruction the passengers including ladies and children are suffering badly. He tried to take control over the situation and requested the above noted persons to start negotiation other than the road and allow the vehicles to ply smoothly. The said persons created obstruction among the police persons to do so and applied criminal forces upon them by assaulting with fist and blows. This results grievous injury upon ASI Rabin Mukherjee on his left jaw, chest and other parts of body and got a dislocation of his teeth. Accordingly he was shifted to Banda R.H. Hospital, Chelyama and after treatment he was referred to Raghunathpur SS Hospital for better management. The said officer is not in a condition to conduct raid. Hence, I conducted raid and arrested above noted 05 persons and SI. No. 6 i.e. Bibek Singh and others could not be arrested after holding raid.

Therefore, on behalf of said officer and being In-charge of this unit I do hereby submit complaint before you against (i) Sujit Mahatha (38Y), S/O Lt. Rabi Mahatha, (ii) Ambuj Mahatha (55Y), S/O Lt. Bharat Mahatha, (iii) Radheshyam Gorai (37Y), S/O Dhiren Gorai All of Vill. - Poradih, (iv) Jiten Kumbhakar (43Y), S/O Lt. Santiram Kumbhakar, (v) Manab Kumbhakar (52Y), S/O Lt. Tarapada Kumbhakar both of Vill. - Aguitard, (vi) Bibek Singh, S/O Dijen Singh of Vill. - Poradih, all of PS - Santaldih, Dist. - Purulia and 3/4 others to start a case under proper section of law.
