Sub:- Complaint regarding physical assault to my driver &
threatening me & my son with filthy languages.

Sir,

With due respect and humble submission, I am to state that I, Smt. Chumki Sen, W/o- Sri Lalit Sen, a resident of vill. & P.O- Saltore, P.S- Neturia. My husband is a Deputy Magistrate, currently posted at Tamluk, Sub-Division in the district of Purba Medinipur. Yesterday (17.09.2023, Sunday) at about 9:20 P.M when I was going to Madhukunda Station from my residence with my driver (Sri Niranjan Bauri of Saltore) and my 13 year old son to receive my husband, Sri Lalit Sen who was coming from Tamluk. Suddenly an unknown person, aged about 25-30 years, forced to stop our car by guarding his motorcycle (Bearing No. WB 82- A 5007) in front of our car in between Balitora High School and Madhukunda station. All of a sudden, the unknown man started to abuse and beat my driver and assaulted him brutally by laying down on the ground and snatched the key of our car and tried to move from the spot. Then, I protested to bring back the key. As a result, he became more furious and about to beat me and threatened to assault me physically. He also uttered filthy language to me which cannot be spoken. Most probably, he was drunken and struck my car with legs repeatedly and some portion of the car has been damaged. I became very much nervous and shocked by such an incident. However, I managed to collect the key from him and started moving towards Madhukunda Station. I am deeply frustrated and afraid. Later on, I informed everything about the matter to my husband and went to Neturia, P.S and they advised us to lodge the complaint to Santuri, P.S as the place is under the jurisdiction of Santuri, P.S. My husband and I intimated the entire matter to you last night over the phone. Today, I am lodging the written complaint against the miscreant.

Under the above circumstances, I pray for your goodself to be kind enough to take legal steps against the accused person immediately.
