
In producing herewith 03 (Six) accused persons namely (1) Rabi Bouri (33 Yrs) S/O Lt. Gopal Bouri of Jhupri, Near Choto Hospital, Adra PS- Adra Dist- Purulia (2) Rohit Agarwal @ Golu (30 yrs), S/O-Nandalal Agarwal of Bata More, PS-Adra, Dist-Purulia (3) Bishnu Singh @ Amit Singh (38 Yrs) S/O Lt. Shyamdev Singh of Vill-Kamlasthan, PS-Adra, Dist-Purulia along with seized articles such as 1. One Iron Bhojali having wooden butt having length of approx 15.00 inch 2. One Iron rod which is one side arrow headed having length of approx 4½.ft. 3. One Screw Driver length approx 1.5 ft

I SI Uttam Kumar Mandal do hereby submit that on 11.10.2023 at 20:45 hrs while performing evening mobile duty vide C.C. No-2779/23, Dated- 11.10.2023, received a source information that 05-08 persons were assembled beside Adra-Kashipur pitch Road near Shantidham Bridge with a view to commit Dacoity. I informed the matter to I/C Adra PS and as per order of I/C Adra PS, I along with forces namely 1) C/ 958 Subhas Bauri 2) C/522 Ruplal Tudu 3) NVF/969 Praloy Mahato all of Adra PS left for Shantidham Bridge to work out the said information.


I along with force reached at Shantidham Bridge at about 21:05 hrs by keeping the police vehicle at a distance of 200 meters (approx) away. Then we approached to the Shantidham Bridge area. We heard suspicious human voices at a distance from 25-30 meters, talking amongst them. I also found 07-08 persons were assembled there and after having heard and seen this, I along with forces confronted suspicious character as police party and they tried to flee away from the spot, but we able to apprehend above noted 03 persons. On being asked they disclosed their identity as noted above. Rest 04-05 persons fled away from the spot due to the darkness as well as the topography of the locality. Then I offered the detained persons to search me and my Police party before searching their body, but they refused. After that we searched them. During search I found 1. One Iron Bhojali having wooden butt having length of approx 15 inch recovered from the possession of Rabi Bauri. 2. One Iron rod which is one side arrow headed having length of approx 4½.ft recovered from the possession of Rohit Agarwal, 3. One Screw Driver length approx 1.5 ft recovered from the possession of Bishnu Singh @ Amit Singh. On interrogation the accused persons disclosed their names and address as noted above and confessed that they were assembled there for committing Dacoity at Adra Market area during this night. So, I seized the above noted articles along with above noted vehicles and labeled duly signed by the police witnesses as no local witnesses available there then arrested them informing the ground of arrest, observing all arresting guidelines. As it was evident during our raid the accused persons assembled at a solitary place and were preparing amongst themselves with weapons found in their possessions for committing Dacoity at Adra Market area, actually committed an offence punishable U/S- 399/402 IPC. In view of this I arrested the above noted 03 (Three) accused persons and seized the weapons from their possession by preparing proper seizure list on the spot duly signed by the accused persons as well as police party and brought them to P.S. The whole process was done i.e. search, seizure, and arrest in between 21.25 hrs to 22.15 hrs.

Hence I pray a specific case may kindly be started against (1) Rabi Bouri (33 Yrs) S/O Lt. Gopal Bouri of Jhupri, Near Choto Hospital, Adra PS- Adra Dist- Purulia (2) Rohit Agarwal @ Golu (30 yrs), S/O-Nandalal Agarwal of Bata More, PS-Adra, Dist-Purulia (3) Bishnu Singh @ Amit Singh (38 Yrs) S/O Lt. Shyamdev Singh of Vill-Kamlasthan, PS-Adra, Dist-Purulia & other 04/05 unknown miscreants under proper section of law and arrange its investigation.
