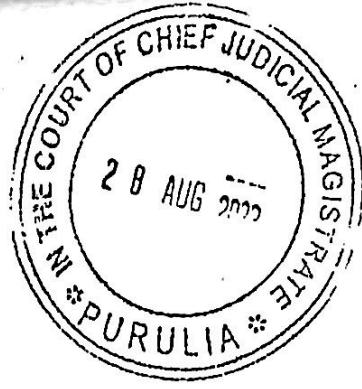

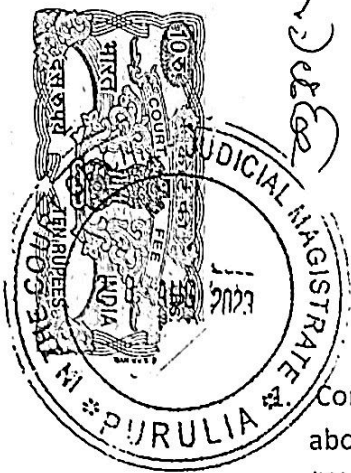

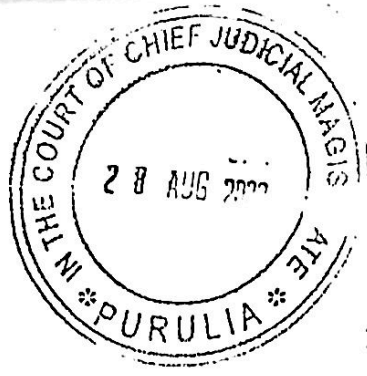
- 1----That your petitioner , the witnesses and the accused person are the residents of the same village Jhunjka, under P.S. Arsha , District Purulia .

The accused has duly accept the consideration money from the petitioner and his brother and father .

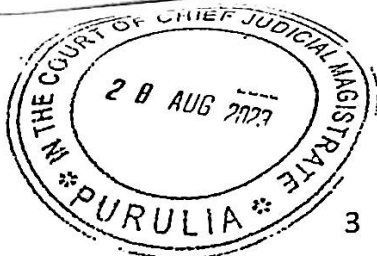
3----That it may be mentioned here that prior to execution of the sale deeds in favour the petitioner and his brother and father and subsequent thereafter the accused Harun Momin , sold away the aforesaid lands of the said Moua to different persons like Pal Kumar, Bhagirath Kumar, Sagar kumar , Adhir Chandra Majhi, Kirity bhusan Majhi, shaktipada Majhi , Subhash Sahis, Pradip Sahis, Janik Rewani and Manik Rewani in order to deceit and cheat the petitioner for the wrongful gain of the accused and wrongful loss of the petitioner and his brother and father .

4----That though the accused Harun Momin aware that he has no remaining lands over those plots still then for his wrongful gain and for wrongful loss of the petitioner and his brother and father and in order to deceive and cheat the petitioner and his brother and father , the accused has execute and registered sale deed bearing No.3429 and 3076 in favour of the petitioner and others .

5----That on 02-08-2023, the aforesaid Pal Kumar, Bhagirath Kumar , Sagar, Kumar Adhir Chandra Majhi, Kirity Bhusan Majhi , Shaktipada Majhi , Pradip Sahis, Subhash Sahis , Janik Rewani and Manik Rewani came in the aforesaid lands and disclosed that they have purchased the lands from accused Harun Momin and showed their L.R. Khatians in respect of the aforesaid lands purchased by the petitioner and others . Your petitioner believed that he and his brother and father has been cheated by the Accused Harun Momin and rushed to the house of Harun Momin and asked him as to why he has cheat the petitioner ? At this the accused Harun Momin became furious and asked the petitioner to leave the place immediately other wise dire consequence would follw he threatened and supported the other purchasers.

6----That there after your petitioner informed the matter to the local police station . The duty officer assured your petitioner to take legal action against the culprit but no specific case has been started against the accused person by the police best known to them . Again your petitioner and his P.W.s went to police station to enquire about the fate of his complaint .

7---That your petitioner is a helpless and poor man having no source of income . He is not in a position to pull the case in his own cost . Moreover , there are some technical and legal aspect involved in this case which also requires considerable money and machinery .So, it is highly desirable that this case should be converted to a Police case .

It is prayed that your Honour may be graciously pleased to direct the Officer in Charge Arsha Police Station to investigate the case in accordance with law treating the same as F.I.R. as contemplated U/S 156 (3) Cr.P.C.
