

Sub: To lodge FIR against owner and driver namely Uttam Majhi (35 yrs) S/O Khedan Majhi of Vill-Satra, PS- Arsha, Dist. Purulia of one Mahindra **D**275 DI tractor having Reg. No. WB55B/4075, Engine No. RLG2EMN0994, Chassis No. MBNABAEXKLJG03039 along with trolley loaded with sand (approx 60 CFT).

Sir,

In producing herewith, 01 (one) Mahindra B275 DI tractor having Reg. No. WB55B/4075, Engine No. RLG2EMN0994, Chassis No. MBNABAEXKLJG03039 along with trolley loaded with sand (approx 60 CFT). To the effect that during my evening mobile duty vide C.C No. 2649/23 Dtd. 14/10/23 acting on source information & as per direction of O/C, Arsha P.S, I ASI Tapan Kr Mahata of Arsha PS along with (i) C/-146 Maheswar Singh Sardar of Arsha PS and (ii) C/252 Nishan Alam of SAP 7th BN camp at Arsha P.S, Dist-Purulia reached at Satra Sand Ghat under Arsha PS at 20.35 hrs, we conducted raid at Satra sand ghat on the Bank of River Kansai under Arsha PS and found 01 (one) tractor along with trolley attached with by a hinge was present at Satra Sand Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Satra sand Ghat, fled away. Police rushed to the tractor and detained the said tractor as well as driver namely Uttam Majhi (35 yrs) S/O Khedan Majhi of Vill-Satra, PS-Arsha, Dist. Purulia. I asked him to show valid document in respect of loaded sand but he failed to produce any document. Hence, I seized the above noted tractor along with trolley loaded with sand (approx 60 cft) and arrested the driver namely Uttam Majhi (35 yrs) S/O Khedan Majhi of Vill- Satra, PS- Arsha, Dist. Purulia with proper arrest memo & following all the guidelines as laid down by the Hon'ble Apex Court. After that, I brought the tractor and the arrested driver to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and were doing illegal activities vide Memo No. V1/430/(Part-VIII)/2187/1(51)/M/17 Dtd. 03.07.2023 & Memo No. VI/430/(Part-VIII)/ 3326(51)/M/17 of the DM, Purulia.

Hence, I do hereby lodge this complaint against the owner and driver namely Uttam Majhi (35 yrs) S/O Khedan Majhi of Vill- Satra, PS- Arsha, Dist. Purulia of above noted tractor having Reg. No. WB55B/4075, Engine No. RLG2EMN0994, Chassis No. MBNABAEXKLJG03039 along with the trolley loaded with sand (approx 60 cft) for investigation.
