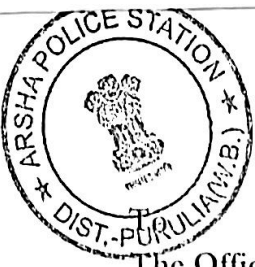

Sub: To lodge FIR against owner and driver of one POWERTRAC 437 tractor having Reg. No. WB55B/3095, Engine No. E3538187, Chassis No. T053478032LJ along with trolley loaded with sand (approx 60 CFI).


In producing herewith, 01 (one) POWERTRAC 437 tractor having Reg. No. WB55B/3095, Engine No. E3538187, Chassis No. T053478032LJ along with trolley loaded with sand (approx 60 CFI). To the effect that during my evening mobile duty vide GDE No. 1191 Dtd. 29/10/23, acting on source information & as per direction of O/C, Arsha P.S, I SI Mrinmay Bhakta of Arsha PS along with (i) C/-1479 Anup Kr. Mahato of Arsha PS and (ii) C/252 Nishan Alam of SAP 7th BN camp at Arsha P.S, Dist-Purulia reached at Bhandu River Ghat near Arsha College, under Arsha PS at 16.15 hrs, we conducted raid on the Bank of Bhandu River under Arsha PS and found that 01 (one) tractor along with trolley attached with by a hinge was present at Bhandu River Ghat near Arsha College on the Bank of Bhandu River. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Bhandu River Ghat near Arsha College, fled away. We rushed to the tractor and detained the said tractor. Then we searched the said tractor and found that the tractor was loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending tractor. Hence, I seized the above noted tractor along with trolley and brought the tractor to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and were doing illegal activities vide Memo No. VI/430/(Part-VIII)/2187/1(51)/M/17 Dtd. 03.07.2023 & Memo No. VI/430/(Part-VIII)/ 3326(51)/M/17 of the DM, Purulia.

Hence, I do hereby lodge this complaint against the owner and driver of above noted POWERTRAC 437 tractor having Reg. No. WB55B/3095, Engine No. E3538187, Chassis No. T053478032LJ along with the trolley loaded with sand (approx 60 cft) for investigation.
