Sir,

In producing herewith the one accused person namely Bablu Mahato (43 Yrs), S/O-Lt-Sanu Mahato of Vill-Ghorabandha, PS- Baghmundi, Dist-Purulia along with seized article **11 (Eleven) bottle of IDL containing 900 ml each bottle i.e 09 ltr-900 ml** which was seized under proper seizure list duly signed by the witnesses.

I beg to submit that today on 16.10.2023 during my special raid duty as per Baghmundi PS C.C No- 3559/2023, Dtd: 16.10.2023 received source information. Accordingly, I SI Gokul Ch. Ruhidas along with force 1. C/916 Raj Kumar Mahato & 2. C/2946 Ashim Kumar Singha Mahapatra of Baghmundi PS, Dist-Purulia reached at Ghorabandha village at about 14:55 hrs and found that the above noted person is selling I.D liquor in his hotel premises name & style as Baba Hotel. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. In between 15:05 hrs to 15:25 hrs I seized **11 (Eleven) bottle of IDL containing 900 ml each bottle i.e 09 ltr-900 ml** from his sole possession U/S- 67 B.E Act which was seized under proper seizure list duly signed by the witnesses. The seized article was labeled properly in presences of witnesses and accused person. Hence I arrested the above noted -person at 15:35 hrs after maintaining all formalities and guidelines regarding arrest. I offered him for medical treatment but he refused.

The above noted arrested accused person namely Bablu Mahato (43 Yrs), S/O-Lt-Sanu Mahato of Vill-Ghorabandha, PS- Baghmundi, Dist-Purulia committed an offence U/S- 46 (A)(c) B.E Act 1909 for unauthorized possession and selling of ID Liquor from his sole possession.

Under the fact and circumstances I therefore pray before you a specific case may kindly be started against the said accused person under proper section of law and arrange its investigation.
