Sub: Request for lodging F.I.R. against Unknown miscreant.

Sir,

I, SI Gokul Ch. Ruhidas of Baghmundi PS do hereby lodged suomoto typed complaint to the effect that on 10.10.2023 at 11:15 hrs received a written information from MO, Pathardih BPHC namely Dr. Biswarup Boxi regarding a brought dead unknown male patient aged about 35 Yrs, later on the patient has been identified as SK Afroz, S/O- SK Lukman of Vill-Deogan, PO-Kusumi, PS-Badampahar, Dist-Mayurbhanj, State-Odisha. Over this information Baghmundi PS U/D case No. 31/2023 dtd. 10.10.2023 had been started and as per endorsement I hold surathal report over the dead body of deceased SK Afroz at Pathardih BPHC. During surathal several injuries found all over the body and blood stain found on her face and body. There after arranged to send the dead body of deceased SK Afroz, S/O- SK Lukman of Vill-Deogan, PO-Kusumi, PS-Badampahar, Dist-Mayurbhanj, State-Odisha to Purulia Deben Mahato Govt. Medical College & Hospital, Purulia through escort C/835 Lekaram Bauri for PM examination to ascertain actual cause of death.

Collected PM report of deceased SK Afroz, S/O- SK Lukman of Vill-Deogan, PO-Kusumi, PS-Badampahar, Dist-Mayurbhanj, State-Odisha vide PM No. 902/2023 dtd. 10/10/2023 in which Autopsy Surgeon Dr. Arundhati Saha, Senior Resident, Department of Forensic Medicine & Toxicology, Deben Mahato Govt. Medical College & Hospital Purulia opined that "Death was due to the effects of the ante mortem injuries noted above".

Later on during enquiry, it was revealed that on 10.10.2023 early morning information received that one white colour Bolero car bearing Reg No-OR11J/5775 capsized and fell down 40ft deep on Ajodhya to Loharia road near Lower dam switch yard where the dead body of the deceased namely SK Afroz had in the middle seat of the said bolero car. Dead body of the deceased brought by one Mithun Kumar at Pathardih BPHC, PS-Baghmundi, Dist-Purulia. I strongly believe that deceased SK Afroz (35 Yrs), S/O-SK Lukman of Vill-Deogan, PO-Kusumi, PS-Badampahar, Dist-Mayurbhani, State-Odisha was murdered by unknown miscreants.

As the cause of death is due to the effects of the ante mortem injuries, So, I am submitting complaint against unknown miscreants for starting a specific case and also arrange for its investigation.
