The humble petition on behalf of the above named complainant;

- 1. That the above named complainant is an old aged senior citizen having permanent resident of Village- Bardih under P.S.-Balarampur, District- Purulia (W.B.) and within the jurisdiction of this Ld. Court.
- 2. That one Thakabala Kumarin, the mother of the complainant had considerable landed properties in her name in Mouza-Latadaha, under P.S.- Balarampur, District- Purulia, being lawful owner and she used to possess the same by cultivating paddy therein till her death and the L.R. Khatian being No. has been duly recorded in respect of R.S. Plot No. 906, 920, 921, 924, 925, 4166 and 4167 having a total area of 78 decimals.
- 3. That after her death on 10/05/1984 the complainant being her only legal heiress and representative inherited all the lands in said L.R. Khatian No. 346 left by her mother and she was/is in actual physical possession over the same uptill now.
- 4. That in the first part of the month of August 2022, the accused person No. 1 first time disclosed in the locality that his name has been recorded in respect of the entire properties left by Thakabala Kumarin being her legal heir.
- 5. That after searching the complainant obtained certified copy of an order dated 18/04/2022 in connection with Case No. WR/2022/1409/514 on 22/08/2022 from the concerned office of the B.L. & L.R.O. and reveals that the accused person no. 1 has mutated his name in the office of the B.L. & L.R.O. Balarampur in respect of the entire lands of Thakabala Kumarin in L.R. Khatian No. 376 and a new L.R. Khatian No. 1392 has been prepared to that effect. ↑rom 06/04/M
- 6. That the complainant thereafter preferred an appeal before the A.D.M. -cum-D.L. & L.R. Officer, Purulia against such order vide Misc. Appeal No. 98/2022 and accordingly after hearing the Appellate Authority has been on 01/06/2023 pleased to set aside the said impugned order dated 18/04/2022 in Case No. WR/2022/1409/514.





- 7. That in the said case, the accused person No. 1 obtained Mutation in his name in respect of the landed properties of said Thakabala Kumarin being her only legal heir by producing a fake and false Death Certificate -cum-Legal Heir Certificate before the concerned office of the B.L. & L.R.O. Balarampur.
- 8. That there was/is no any blood relation in between the accused person No. 1 was /is the legal heir of deceased Thakabala Kumarin.
- 9. That on the basis of said erroneous and illegal L.R. Khatian the accused person No. 1 and his sons are trying to dispossess the complainant from the said property by show of their muscles force and for that they are continuously giving out threats to her with dire consequence.
- 10. That the accused person No. 1 also sold out some and in R.S. Plot No. 925 to the accused person No. 5 on the basis of said illegal and erroneous L.R.R.O.R. by dint of Registered Deed.
- 11. That all the accused persons in collusion with each other with a view to take over illegal possession over the said entire landed properties giving out threatening and to show fear to the complainant and on protest they all abused filthy and defamatory languages as well as threats to murder the complainant.
- 12. That the accused person No. 1 in conspiracy with the Pradhan of Ghatbera Kerowa G.P. manufactured a forge, fake and false Death Certificate cum-Legal Heir Certificate and obtained mutation by producing the same before the concerned B.L. & L.R. Office which is not only committed cheat to the complainant but to with the Government also.
- 13. That the complainant is a vey poor, lonely, peace-loving law abiding old aged lady and taking advantage of the same, the accused persons with a view to grab the entire properties put mental pressure upon the complainant so that they can illegally and forcefully take possession over the same by depriving the complainant from her legitimate right.







14. That in such facts the complainant has been sustained very mental pain and agony and she also passing her days with great fear and also apprehends that the accused person may cause mischief over the properties by physically assaulted the complainant in near future.



15. That the accused persons are all very dangerous and desperate and greedy nature and they have committed cheating to the complainant as well as to the Government which shows their malafide and criminal intention and for their such illegal act they are rendering themselves liable to be prosecuted for the offences punishable under the Law.

16.That the complainant on 10/06/2023 lodged a written complaint before the O.C. Balarampur P.S. by Registered Post with A.D. to that effect but as the Police did not takes any steps so the complainant again lodged written complaint before the S.P. of Purulia on __OJ.OJ. 2023 __ but inspite of receipt of the same, no action was taken by the Police till date and as such finds no other alternative but the complainant has been compelled to file this petition before this Ld. Court for seeking relief as per Law.

17. That the complainant is a very simple, poor, Law-abiding senior citizen and has no adequate means to file a regular case as well as to incur the expenses of the Court fees and other expenditure in proper and regular way.
