Sir,

I, ASI Surendra Nath Soren along with force returned to P.S and brought 02 (two) seized Tractors attached with 02 (two) trolley as 1) One Blue colour Tractor having registration No- WB55B/1794 (Model-Swaraj 735FE) loaded with approx 50 cft. sand & 2) One Red colour Tractor (Model- Mahindra 475DIMKMBLX) having Chassis No- MBNABAJBALRE01767, Engine No- RLE2KBA1597 loaded with approx 50 cft. sand. The fact in brief is that today (12.10.2023) I along with force namely C/2091 Gurupada Dhal, C/119 Budhadeb Mandal and CD/234 Bisam Hansda were performing mobile duty at Balarampur P.S area vide Balarampur P.S GDE No- 545 Dated- 12.10.2023 in c/w Balarampur P.S C.C No- 4180 Dated- 12.10.2023. During my mobile duty I received a credible source information that 02 (two) Tractors were lifting & carrying sand illegally and coming from Nekre village side through Patharbandh village side Pitch road which is coming towards Daldiri. Subsequently, I informed you and as per your order, I work out the said information. Thereafter myself along with force held raid at Nekre village near small river and found the above noted 02 (two) tractors were proceeding towards Daldiri. Consequently, when we intercepted the said Tractors at about 13:05 hrs but seeing the Police party, 02 (two) tractors along with sand loaded trolley turned around and flee away from there. We manage to apprehend the said above noted 02 (two) tractors and we were able to detain the said 02 (two) tractors but the driver of above noted tractors flee away. We tried to apprehend them but failed. We waited for reasonable time but none came to spot. It was ascertained that the drivers of the tractors loaded the said sand in cahoots with the owners of the Tractors by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasonable to belief that they in cahoots with the owners of the offending tractors procured the said sand from small River under Balarampur P.S area by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the 02 (two) tractors attached with 02 (two) trolley having 1) Registration No. WB55B/1794 (Model-Swaraj 735FE) loaded with approx 50 cft. sand & 2) One Red colour Tractor (Model- Mahindra 475DIMKMBLX) having Chassis No- MBNABAJBALRE01767, Engine No- RLE2KBA1597 and loaded with 50 cft sand each under proper seizure list in presence of witnesses duly signed by them. Thereafter, I brought the said 02 (two) tractors along with sand loaded 02 (two) Trolley to Balarampur P.S compound.

Under the above facts and circumstances kindly take lawful action against the Owners & drivers of the said offending 02 (two) tractors as they committed offence U/S 379/411/414 of the IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957
