Respected Sir,

In producing herewith two accused persons namely 1) Anil Prasad (48 yrs) S/O- Lt. Laxman Prasad of Dimna Basti, Mango, P.S- Mango, Dist- East Singhbhum, JKD & 2) Arun Kumar (42 yrs) S/O- Lt. Amulya Kumar of Vill- Baghdih, P.S. Balarampur Dist- Purulia along with two (02) seized Motorcycles as per seizure list. I Satrughna Mahato of Balarampur P.S beg to state that today i.e on 18.10.2023 at about 03:45 hrs (AM) while myself along with force 1) C/1478 Dharendra Nath Mahato, 2) C/2332 Rajendra Nath Bera, 3) C/204 Sudip Sasmal, 4) HG/1907 Mutuk Singh Sardar (vide Balarampur GDE No- 805 date 17.10.2023 & CC No- 4280/2023 date 17.10.2023) were engaged in NAKA Checking duty at Dantia (Interstate JKD Border) under Balarampur PS. We found one motorcycle was coming from Tata side without its number plate and I signed to stop him & checked one Black-Silver Colour "HERO SPLENDER Motorcycle having its Chassis No- MBLHAW128LHC10924 & Engine No- HA11EYLHC04575 in which above noted person was boarded & I asked to provide the valid paper in respect of the above noted Motorcycle but no sooner I had asked for the papers than he started stammering that led to suspicious. Further, I asked for the papers regarding ownership but neither could he provide any proper valid document related to the motorcycle nor could give any satisfactory reply pertinent to the Motorcycle. On further interrogation, he confessed that he (accused) has stolen that bike & taken it to Balarampur for selling as he used to do it. Further he also revealed that he recently sold another motorcycle to one Arun Kumar (42 yrs) S/O- Lt. Amulya Kumar of Vill- Baghdih, P.S. Balarampur Dist- Purulia & with him habitually dealing in stolen property (motorcycle) since last few years.

Accordingly I seized the aforesaid Motorcycle having its Chassis No- MBLHAW128LHC10924 & Engine No- HA11EYLHC04575 under proper seizure list duly signed by accused person & accompanied Police Personnel and arrested the accused Anil Prasad (48 yrs) S/O- Lt. Laxman Prasad of Dimna Basti, Mango, P.S- Mango, Dist- East Singhbhum, JKD under proper formalities.

After that I along with force and accused person went to the house of Arun Kumar (42 yrs) S/O- Lt. Amulya Kumar of Vill- Baghdih, P.S. Balarampur Dist- Purulia where he identified the previous sold motorcycle to Arun Kumar. I interrogated to Arun Kumar very carefully who confessed that he along with Anil Prasad habitually dealing in stolen motorcycle since last few years.

The aforesaid two accused persons also stated that they have accumulated more stolen motorcycles for purpose of habitually dealing in stolen motorcycle by theft since last few years. I seized the following Motorcycle from the house of Arun Kumar after preparing seizure List duly signed by the accused person & Police personnel as 1) One H.G Blue Colour Hero Honda Splender Motorcycle having its Reg No-JH05AX/3128, Chassis No- MBLHA10A3DHL49594, Engine No-HA10ELDHL62042

In accordance with law & adhering all guidelines, I arrested the another accused person namely Arun Kumar (42 yrs) S/O- Lt. Amulya Kumar of Vill- Baghdih, P.S. Balarampur Dist- Purulia and brought them (accused Anil Prasad & Arun Kumar) with seized articles.



Therefore, I pray that a specific case may kindly be registered against the following persons namely 1) Anil Prasad (48 yrs) S/O- Lt. Laxman Prasad of Dimna Basti, Mango, P.S- Mango, Dist- East Singhbhum, JKD & 2) Arun Kumar (42 yrs) S/O- Lt. Amulya Kumar of Vill- Baghadih, P.S. Balarampur Dist- Purulia U/S- 379/411/413/414 IPC.
