Respected Sir,

In producing herewith one arrested accused person namely Dilip Gorai (47 Yrs), S/O Lt. Gangadhar Gorai of Village- Salbani, PS- Bandwan, Dist- Purulia to start a Specific Case U/S 46A(C) B.E. Act 1909 with the seized articles i.e. **approx 08 litre illicit distil liquor in a white jerrican marked as Exhibit "A" & 01 Litre has been taken out in one separate bottles from mother quantity as sample marked as Exhibit "B"**. I beg to submit that on 18/10/2023 at about 17.45 hrs. I received a credible source information while I was engaged in Mobile duty that one person namely Dilip Gorai of Village- Salbani, PS- Bandwan, Dist- Purulia is stocking and selling Illicit Distill liquor without any valid license from his dwelling house. Accordingly, myself along with C/340 Baman Das Goswami & C/59 Ahlad Rajak all of Bandwan P.S., Dist-Purulia vide Bandwan P.S. C.C. No. 3595/23 Dtd: 18/10/2023 left for Salbani village to work out the said source information and held raid at the dwelling house of Dilip Gorai at 18:25 hrs where the above mentioned accused person has stocked Illicit liquor for selling. Being asked, he disclosed that whole quantity of liquor has been stocked for the purpose of selling. On demand, he failed to produce any valid documents/ License in respect of stocking and selling of Illicit Distilled liquor. Accordingly, I seized all the Illicit Distilled liquor (details in attached seizure list) in between 18:30 hrs to 18:45 hrs and prepared proper seizure list duly signed by the witnesses. Then, I arrested him at 18:55 hrs, prepared arrest memo as per his revealed identity as noted above maintaining all legal procedures regarding arrest as laid down by Hon'ble Supreme Court.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(C) B.E. Act 1909 against the arrested accused person namely Dilip Gorai (47 Yrs), S/O Lt. Gangadhar Gorai of Village- Salbani, PS- Bandwan, Dist- Purulia and arrange for its investigation.
