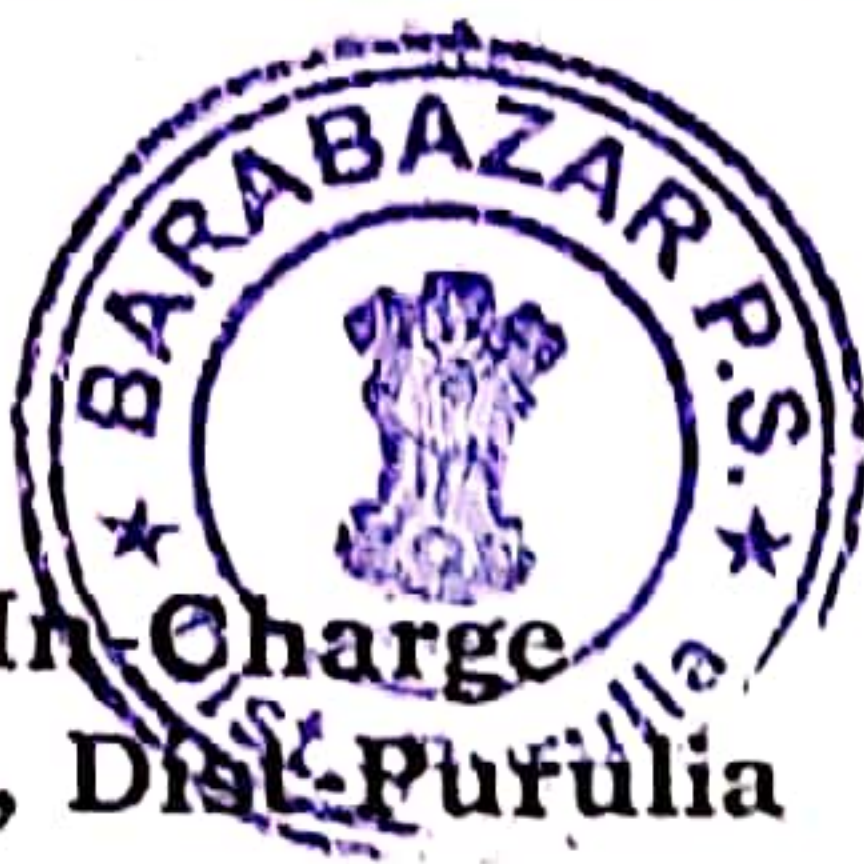

Sub: Complaint against Sanjay Sahish (Male/ 30 Yrs.) S/O- Ananda @ Rijhu Sahish of Village- Sachandih, PS- Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely Sanjay Sahish (Male/ 30 Yrs.) S/O- Ananda @ Rijhu Sahish of Village- Sachandih, PS- Barabazar, Dist- Purulia and seized (i) One white colour plastic jarecane loaded with approx 20 (Twenty) liters I.D liquors (Cholai) from which 500 ml seized as sample from said jarecane in a separate plastic bottle as per enclosed seizure list.

I, SI Debabrata Chakraborty of Barabazar PS do here by lodge this complaint against one Sanjay Sahish (Male/ 30 Yrs.) S/O- Ananda @ Rijhu Sahish of Village- Sachandih, PS- Barabazar, Dist- Purulia. I beg to state that on 07.10.2023 myself along with C/- 1211 Chunaram Hembram & C/- 1494 Manas Mukherjee were left for mobile duty vide Barabazar PS GDE No- 497 Dtd. 07.10.2023. During mobile duty at about 17.45 hrs I received an information that one person was selling I.D liquor in his house at Sachandih village under Barabazar PS. I was there to verify the credibility of that information and immediately informed to the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said place to work out the information.

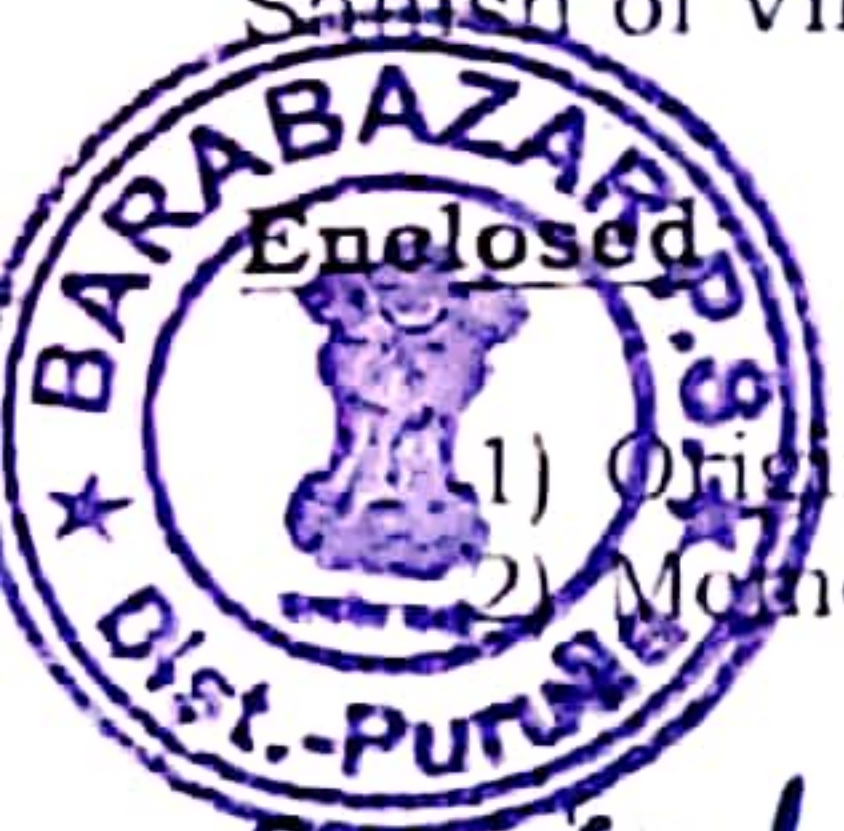
At about 18.15 hrs myself along with force held raid in the dwelling house of Sanjay Sahish (Male/ 30 Yrs.) S/O- Ananda @ Rijhu Sahish of Village- Sachandih, PS- Barabazar, Dist- Purulia and found that he was keeping & selling ID Liquor (Cholai) from his house. Seeing the Police party buyers fled away, but somehow, we apprehended the alleged person who was keeping & selling ID Liquor (Cholai). On search I found (i) One white colour plastic jarecane loaded with approx 20 (Twenty) liters I.D liquors (Cholai). On interrogation, said Sanjay Sahish confessed his guilt and stated that he selling the I.D liquor (Cholai) to the local people with intent to make his own profit. He also admitted that he has no license or any authorization for keeping or selling of I.D liquor (Cholai) and he disclosed his identity as noted above.

Accordingly, I seized the same after preparing proper seizure list and put label on the seized article in presence of witnesses and from which 500 ml of I.D liquor taken as sample in a separate plastic bottle which were also duly labeled by me and also took signature of the accompanying witness on seizure list and label as well as accused person also.

I try to find out local witnesses but no one turn up before me. The seizure and label was done in between 18.15 to 18.35 Hrs.

Thereafter, I arrested the accused person namely Sanjay Sahish (Male/ 30 Yrs.) S/O- Ananda @ Rijhu Sahish of Village- Sachandih, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Accordingly, informed him and his relatives regarding the ground of arrest. The arrest was made on 07.10.2023 at 18.35 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the arrested accused person namely Sanjay Sahish (Male/ 30 Yrs.) S/O- Ananda @ Rijhu Sahish of Village- Sachandih, PS- Barabazar, Dist- Purulia under proper section of Law.
