Sub: Complaint against Abir Mahato @ Bittu (26 Yrs/Male) S/O- Baldeb Mahato of Village- Arabaid, PS-Barabazar, Dist- Purulia to start a specific case under proper section of Law.

In producing here with arrested accused person namely Abir Mahato @ Bittu (26 Yrs/Male) S/O-Sir, Baldeb Mahato of Village- Arabaid, PS- Barabazar, Dist- Purulia and seized (i) 02 (Two) white colour plastic jaricane containing 22 (Twenty-two) liters I.D liquor (Cholai) from which 500 ml ID Liquor (Cholai) both seized as sample in a plastic bottle which kept in two carrying plastic bag in the Motor-cycle bearing Reg. no-WB/56P/2590 (Royal Enfield) and (ii) One black/blue colour Royal Enfield Motor-Cycle bearing Reg. No-WB/56P/2590 having Eng. No- U3S5C1jl872102 and Chassis No. #ME3U3S5C1JL839335# under proper seizure list.

I, SI Mukul Karmakar of Barabazar PS do here by lodge this complaint against one Abir Mahato @ Bittu (26 Yrs/Male) S/O- Baldeb Mahato of Village- Arabaid, PS- Barabazar, Dist- Purulia. I beg to state that on 10.10.2023 myself along with ASI Tarun Bhui, C/- 3218 Sukchand Mandi & C/- 1211 Chunaram Hembram were left for mobile duty vide Barabazar PS C.C No- 5899/23 Dtd. 10.10.2023. During mobile duty at about 18.55 hrs I received an information that one person was Carrying and selling I.D liquor (Cholai) at Arabaid village under Barabazar PS. I was there to verify the credibility of that information and immediately informed to the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the spot to work out the information.

At about 19.05 hrs myself along with force held raid at the village road of Arabaid near Primary School and apprehended one Motor-Cycle having Reg. No- Reg. No- WB/56P/2590 along with 02 (Two) bags containing ID Liquor (Cholai) from the possession of Abir Mahato @ Bittu (26 Yrs/Male) S/O- Baldeb Mahato of Village- Arabaid, PS- Barabazar, Dist- Purulia and found that he was carrying & selling ID Liquor (Cholai) at that locality. On search I found (i) 02 (Two) white colour plastic jaricane containing 22 (Twenty-two) liters I.D liquor (Cholai) from which 500 ml ID Liquor (Cholai) both seized as sample in a plastic bottle which kept in two carrying plastic bag in the Motor-cycle bearing Reg. no- WB/56P/2590 (Royal Enfield). On interrogation, said Abir Mahato @ Bittu confessed his guilt and stated that he selling the I.D liquor (Cholai) by his Motor-Cycle to the local people with intent to make his own profit. He also admitted that he has no license or any authorization for keeping or selling of I.D liquor (Cholai) and he disclosed his identity as noted above.

Accordingly, I seized (i) 02 (Two) white colour plastic jaricane containing 22 (Twenty-two) liters I.D. liquor (Cholai) from which 500 ml ID Liquor (Cholai) both seized as sample in a plastic bottle which kept in two carrying plastic bag in the Motor-cycle bearing Reg. no- WB/56P/2590 (Royal Enfield) and (ii) One black/blue colour Royal Enfield Motor-Cycle bearing Reg. No- WB/56P/2590 having Eng. No-U3S5C1il872102 and Chassis No. #ME3U3S5C1JL839335# under proper seizure list duly signed by the witnesses and labeled by me. The seizure and label was done in between 19.35 to 20.10 Hrs.

Thereaster, I arrested the accused person namely Abir Mahato @ Bittu (26 Yrs/Male) S/O- Baldet Mahato of Village- Arabaid, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Accordingly, informed him and his relatives regarding the ground of arrest. The arrest was made on 10,10,2023 at 20,15 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the arrested accused person namely Abir Mahato @ Bittu (26 Yrs/Male) S/O- Baldeb Mahato of Village- Arabaid, PS- Barabazar, Dist- Purulia under proper section of Law.
