I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that RAMJI MURMU S/O Lt. SUKUMAR MURMU Vill- NAWADIH, Dist- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- DDG348525) From its incoming Service Cable through 02-Core PVC wire and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

On 11.10.2023, I Sri SHIBAJI CHAKRABORTY, J.E, Gr ii, BARABAZAR CCC, WBSEDCL along with

- (1) SANJIT MAHATO, Sr.TSH, BARABAZAR CCC, WBSEDCL
- (2) SURESH SAO, O.E., BARABAZAR CCC, WBSEDCL

At About 12:40 P.M., entered into the premises of RAMJI MURMU S/O Lt. SUKUMAR MURMU Vill- NAWADIH, Dist- Purulia and inspected his premises at Vill.- NAWADIH, P.S Barabazar, DIST- Purulia.

During inspection, it was found that RAMJI MURMU S/O Lt. SUKUMAR MURMU Vill- NAWADIH, Dist- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- DDG348525) From its incoming Service Cable through 02-Core PVC wire in his premises at NAWADIH having connected load 0.12 KVA.

I seized the following articles from the said premises:

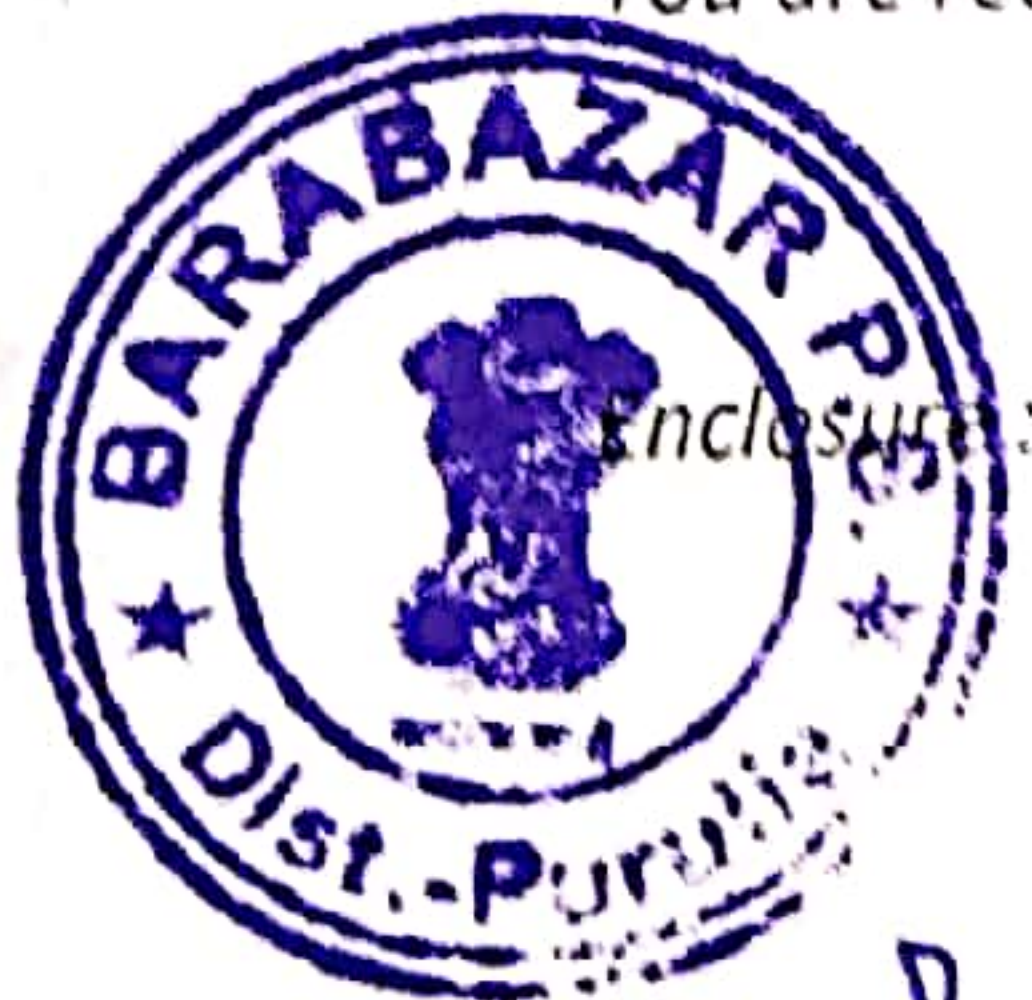
