(i) 20 Sealed Bottles of "Kingfisher Beer @135/- each, 650 ml each, = 13 Litters marked as Exhibit "A", one bottle as sample marked as Exhibit "A-1"

(ii) 02 Sealed bottles of "MacDowell's No. 01" brand RUM @ 290/- each , 375 ml each=0.75 Litters.Marked as Exhibit "B", one bottle as sample marked as Exhibit "B-1",

iii) 8 Sealed bottles of "MacDowell's No. 01" brand RUM @ 150/- each, 180 ml each = 1.44 Litters. Marked as Exhibit "C", one bottle as sample marked as Exhibit "C-1",

iv) 03 Sealed bottles of "MacDowell's Luxury" brand RUM @ 180/- each , 180 ml each =0.54 Litters.Marked as Exhibit "D", one bottle as sample marked as Exhibit "D-1",

v) 02 Sealed bottles of "Officer Choice" whisky @ 150/- each , 180 ml each =0.36 Litters. Marked as Exhibit "E", one bottle as sample marked as Exhibit "E-1",

vi) 02 Sealed bottles of "Blue Lagoon" @ 170/- each , 180 ml each =0.36 Litters. Marked as Exhibit "F", one bottle as sample marked as Exhibit "F-1"

I beg to submit that today 20.10.2023 during my evening mobile duty in between 19.05 hrs to 19.45 hrs acting on secret source information I apprehended the above noted person in his house at Ankro village and found that above noted person illegally stocked and selling above noted foreign liquor to local public. On interrogation he disclosed his name and address as noted above. On demand he failed to produce any valid license or papers in support of selling Foreign liquor from his house. He also stated that he is the owner of the house and admitted that he is selling Foreign liquor since long illegally. Accordingly I seized the above Foreign liquor articles from the house of Bidhan Mandal in presence of witnesses and prepared labels duly signed by the witnesses as well as the aforesaid person.

The above noted arrested accd. Bidhan Ch. Mandal (38 Yrs), S/O- Lt. Manaranjan Mondal of Vill-Ankro, PS - Boro, Dist - Purulia committed an offence U/S- 46A(c) B.E. Act. 1909 for unauthorized and selling Foreign liquor from his sole possession in his own house.

It may note here that during raid (1) C/281 Abhijit Patra, (2) C/357 Gopal Biswas accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Bidhan Ch. Mandal (38 Yrs), S/O- Lt. Manaranjan Mondal of Vill- Ankro, PS - Boro, Dist -Purulia
