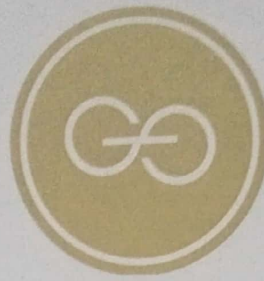

Respected Sir,

I am writing to urgently report a burglary that took place at Geetanjali Granites factory on the night of October 18, 2023. The property is located at Plot-753, Mouza- Shyamnagar, P.S- Hura, Dist- Purulia. According to our CCTV footage, between 3 and 4 unidentified individuals trespassed into the factory premises by scaling the boundary wall and proceeded to steal industrial goods valued at more than Rs. 8,00,000/- (Rupees Eight Lacs).


Given the high value of the stolen items and the severity of the incident, I implore you to prioritize this case and take immediate and effective measures to identify and apprehend the culprits. The security of our factory premises and the ongoing viability of our business are at stake.

For your immediate action, I am including an inventory of all stolen items as Annexure-A with this letter. We are also prepared to provide the relevant CCTV footage for your investigation. Kindly acknowledge this FIR formally and provide me with a copy, indicating that you have commenced your investigation into this serious matter.

I expect swift action and look forward to your prompt attention to resolve this critical issue.
