Sub: Request for lodging F.I.R. against arrested accused person Indrajit Mahato (28 yrs.) S/O- Bhajahari Mahato of Vill- Nimdiha, PS – Hura, Dist – Purulia.

Sir,

In producing herewith arrested accused Indrajit Mahato (28 yrs.) S/O- Bhajahari Mahato of Vill- Nimdiha, PS – Hura, Dist – Purulia along with seized vehicle having registration No WB 55B/5674.

I beg to report that today I ASI Subhendu Mahato along with C/3001 Debashis Mandal and NVF/955 Ganapati Sing Sardar all of Hura PS were performing day mobile duty vide Hura PS C.C No – 3131/23 dtd. 21.10.2023 and while we reached at near Lakhanpur Boys School under Hura PS area at about 10:05 hrs, We found that one Truck bearing Reg. No- WB 55B/5674 was going from Purulia side towards Hura Side On NH 60A with rash and negligently. He also having conversation on mobile phone while driving the said vehicle. We tried to stop him but the driver of the said truck named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such riding. After a hot chase we could be able to stop him near at Lakhanpur Adibasi Hostel On NH60A road under Hura PS, Purulia. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

Accordingly, I seized the Truck having registration No- WB 55B/5674 with a view to prosecute him U/S 279 IPC and 177/184 MV Act. The whole process of seizure was completed in between 10.35 hrs. and 11.05 hrs. I also arrested him at 11.25 hrs. as he violated sec 279 IPC and 177/184 MV Act in presence of police party. His family member was also informed over cell phone about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 177/184 MV Act may kindly be initiated against accused Indrajit Mahato (28 yrs.) S/O Bhajahari Mahato of Vill- Nimdiha, PS – Hura, Dist – Purulia and arrange its investigation.
