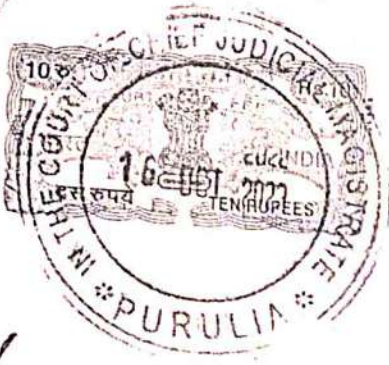

The complainant above named most respectfully begs to state that the complainant is a permanent resident of Tulin Uporpara under Jhalda police station District-Purulia. His marriage was solemnised with Pratima Mahto D/O Shivnath Mahto of Chotamuri, P.S Silli, District-Ranchi (Jharkhand) on 23-4-2017 as per Hindu rites and customs prevailing in our society. After the marriage I took my wife to my house and our marriage was consummated. Thereafter to celebrate Honeymoon we both went to Pari. During this time I noticed some indifferent attitude of my wife towards me but I did not give much stress to that. We returned to our house and were residing in my house. After some days my father-in-law shivnath Mahto and mother-in-law sandhya Devi used to come to our house on short interval and used to meet my wife outside our house and secretly they had conversation, still I did not mind for that. It is mentioned that the distance of my house from my father-in-laws house is only about 8 kilometer.

That my wife gave birth to a male child on 04-03-2021 and after some days as per desire of my wife she went to her father's house and after staying there for few days again came to my house with her parents. After departure of her parents my wife Pratima Mahto started to behave with us all in very cruel manner and started to abuse my parents and me in very filthy language, demanding money, ornaments and others things in order to destroy the peace prevailing in my house and as a matter of fact my wife created the situation in my house rendering all unhappy and worried. I could understand that pratima Mahato committing all such cruelties on my parents as well as me with motive to drive my parents from the house to enjoy her dictatorship in the house. It is mentioned that my father and mother are aged persons.

That in the first week of March 2023 my wife started to tease me provoking to commit suicide and actually she gave me some tablets to swallow which I did and became senseless and I was taken to Jhalda health centre and the Doctor there gave some treatment to me and advised me to get examined by the doctor of purulia sadar hospital and I came to purulia sadar hospital and the doctor there admitted me and I was discharged on 17-03-2023. Still then neither I nor my parent told anything and took exception for the bad deeds of my wife. My wife used to chat over her mobile in the dead of night with somebody, still I did not say or protest to her of her such activities.

That on 14-03-2023 my father-in-law and mother-in-law come to our house afternoon and told me and my parent that they would take my wife to their house for a short stay and will return soon.

That thereafter my wife Pratima did not come to my house though I requested several times to come back to my house but she did not. Thereafter I could learn that my wife Pratima has filed a case in the Jhalda police station and two cases at Ranchi Court in order to harass and humiliate and to put us all in danger. It is also mentioned that pratima Mahto while residing in my house did not take require nursing to my son Dyutiman Mahato Aged about 2+ years. It is also mentioned that my father chittaranjan Mahato and Sanchita Mahato spent about Rs. 5,00,000/- for the education of B.ed course of Pratima Mahato at Ranchi.

That on 22-06-2023 in the evening 1) my father-in-law Shivnath Mahto son of late Karma Mahto 2) Hemant Mahto son of Shivnath Mahto with two other persons seems to be in possession of fire arm all of chota rauri post chota muri P.S. Silli District Ranchi (Jharkhand) came suddenly and entered into our house and at first mishandled my old parents and me and abused in most filthy and ugly language threatening to kill us and in fear we cried loudly and some people like Champa Sao and others came to our house and they horridly retreated. If the witnesses did not come the said

person must have killed us with fire arm. Thereafter considering my wife and my child I did not file any complain to anywhere but thereafter my parent-in-laws and my wife are threatening us over phone to do any mischief on our person and property.

That I approached before the police of Jhalda police station for filling my written complaint but the police officer on duty did not take my complaint for which I sent my above complaint to the inspector of Jhalda police station by registered post on 03/10/2023 but the said inspector did not take any action for which I have filed the copy of my said complaint to the superintendent of police purulia on 07-10-2023 but no action yet been taken from his end for which I have filed this complaint before your Honour today.

The complainant has no such means to start any case out of his own means. It is therefore prays that the said complaint be sent to the inspector of Jhalda Police station under section 156(3) of Cr.p.c. directing to start case and investigate the same of my said complaint.

And for which act kindness your petitioner shall ever pray.
