In producing herewith 01 (One) arrested accused person namely (i) Mansaram Majhi (47) S/O Lt. Sitaram Majhi of Vill-Karior, PO-Rigid, PS-Kotshila, Dist-Purulia under arrest along with seized articles as per seizer list i.e. (i) 20 (Twenty) Ltrs. ID Liquor (Cholai) in a white Plastic Jarican (ii) 18 pieces of plastic glass under proper seizure with label.

I ASI Sisir Kr. Gope of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that today (01/10/2023) myself along with (i) C/1221-Yudhisthir Kumar (ii) C/240-Manoranjan Bagti, (iii) C/1284-Pratapaditya Majhi & (iv) HG/1772-Fatik Ch.-Kumar-all of Jhalda PS were performing night mobile duty (This refers to Jhalda PS CC No. 2855/23 dated 30/09/2023 and GDE No. 1385 dated 30/09/2023. During night morile duty at about 22:35 hrs I received a credible source information that the above noted accused person selling ID Liquor at Kansra village, PO-Mosina, PS-Jhalda, Dist-Purulia. On receipt such information I immediately informed the matter to you and as per your kind direction I along with force proceeded to work out the information. We reached at Kansra village at about 23:55 hours and held raid and found that the accused person namely Mansaram Majhi (47) S/O Lt. Sitaram Majhi of Vill-Karior, PO-Rigid, PS-Kotshila, Dist-Purulia selling ID Liquor at Kansra village. Seeing the Police party the buyers are fled away. On searched (i) 20 (Twenty) Ltrs. ID Liquor (Cholai) in a white Plastic Jarican (ii) 18 pieces of plastic glass were found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villagers illegally. So, finding no any other alternative I seized the above noted articles from the possession of the accused person and labelled, duly singed by the accused person & witnesses in which 500 ML of ID Liquor (Cholai) in a bottle from mother sample was kept as sample with label. During interrogation he confessed his guilt as such I arrested him after observing all the formalities as per law issuing memo of arrest as the accused person are liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely (i) Mansaram Majhi (47) S/O Lt. Sitaram Majhi of Vill-Karior, PO-Rigid, PS-Kotshila, Dist-Purulia U/S-46 A (c) of the Bengal Excise Act 1909.
