and inspected his/ her premises. During the inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest LTOH line of WBSEDCL i.e. U/S 135(1/a) was detected.

From the above arrangement he/she uses the following electrical equipments.

Out of which I seized the following

1. Two core paper insulated cable fitted with hooking device approx length 21 feet's along with one bulb. Seizure list was prepared at the site and accused person refuse to sign/signed.

The inspector team left the premises at 05.25 P.M. on 04/10/2023. The accused person has committed an offence U/S 135(1) (a) of the electricity act-2003 & subsequently electricity (Amendment) act-2007. You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
