

Sir,

In producing herewith 01 (One) arrested accused person namely Rajkishor Mahato (40) S/O Joydeb Mahato of Vill- Basudih, PO-Bonta, PS-Silli, Dist-Ranchi, JKD under arrest along with seized articles as per seizer list i.e. (i) 25 (Twenty Five) Ltrs. ID Liquor (Cholai) in a white Plastic Jarican (ii) 01 Motor Cycle having Reg. No- JH01AG 3778 under proper seizure with label.

I SI Sanjib Kr. Chatterjee of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that today (07/10/2023) myself along with (i) C/2182-Md. Safiul Khan (ii) C/1221 Yudhistir Kumar, (iii) NVF/778 Samir Mahato & (iv) HG/1681 Manmatha Kumar all of Jhalda PS were performing evening mobile duty (This refers to Jhalda PS CC No. 2940/23 dated 07/10/2023 and GDE No. 325 dated 07/10/2023. During evening mobile duty at about 19:45 hrs I received a credible source information that the above noted accused person transporting ID Liquor from Silli, JKD side towards Bagmundi, Purulia side on Jhalda Bagmundi Road, PS-Jhalda, Dist-Purulia. On receipt such information I immediately informed the matter to you and as per your kind direction I along with force proceeded to work out the information. We reached at Jargo more on Jhalda Bagmundi Road at about 20:15 hours and intercepted 01 (one) Motor Cycle bearing Reg. No- JH01AG 3778 and found that the above noted accused person namely Rajkishor Mahato (40) S/O Joydeb Mahato of Vill- Basudih, PO-Bonta, PS-Silli, Dist-Ranchi, JKD was transporting ID Liquor in a white Plastic Jarican. On searching 25 (Twenty Five) Ltrs. ID Liquor (Cholai) in a white Plastic Jarican was found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually transporting the same to the villagers illegally. So, finding no any other alternative I seized (i) 25 (Twenty Five) Ltrs. ID Liquor (Cholai) in a white Plastic Jarican (ii) 01 Motor Cycle having Reg. No- JH01AG 3778 from the possession of the accused person and labelled, duly singed by the accused person & witnesses in which 500 ML of ID Liquor (Cholai) in a bottle from mother sample was kept as sample with label. During interrogation he confessed his guilt as such I arrested him after observing all the formalities as per law issuing memo of arrest as the accused person are liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Rajkishor Mahato (40) S/O Joydeb Mahato of Vill- Basudih, PO-Bonta, PS-Silli, Dist-Ranchi, JKD U/S- 46 A (c) of the Bengal Excise Act 1909.
