To The Inspector In-Charge Jhalda P.S. Dist. Purulia

Sir.

I, SI- Goutam Kr. Bangal along with force returned to PS with 01 (one) arrested accd. person namely Bikash Kumar Mahato (23) S/o Naresh Mahato of village-Chitarpur, PS-Rajrappa, Dist-Ramgarh (Jharkhand) along with seized article i.e. one seized Motor cycle having registration No. JH-01AC2178, Chassis No-MD20HDHZZSC005038, Engine No-DH101582 (One motor cycle black colour Bajaj Boxer) loaded with approx 1.5 Quintal of steam coal under proper seizure list and produced before your good self.

The fact in brief is that today (15/10/2023) myself along with force namely C/814-Susabhan Goswami, C/1221-Yudhistir Kumar, NVF/933-Abani Kumar, & HG/1636-Harekrishna Ghosh were performing evening mobile duty in PS area vide Jhalda P.S. GDE No- 721/23 Dated- 15/10/2023 in consonance with Jhalda PS CC No- 3033/23 Dated- 15/10/2023. During my evening mobile duty, at about 19:55 hrs, received a tip off that 01 (one) unauthorized Motor Cycle loaded with stolen steam coal was coming from Jharkhand side along Kushi more on Iloo Jargo road towards Jhalda. Subsequently, I informed to you and the duty officer and asked him to note down GDE vide No 729 dated 15/10/2023. Consequently, as per your kind order I started Naka at near Kushi More by placing the guardrail on the Iloo Jargo road. Thereafter I saw the 01 (one) Motor Cycle was proceeding towards Kushi more. Consequently, we intercepted the said Motor Cycle at Naka checking point at about 20:35 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party rider who was on that Motor Cycle tried to flee away. After hot chase we managed to apprehend him and the said Motor cycle having registration No. JH-01AC2178, Chassis No-MD20HDHZZSC005038, Engine No-DH101582. On being asked, the rider of the Motor Cycle disclosed his identity as noted in the supra. I asked the rider of the Motor Cycle to produce the valid documents in respect of the Motor Cycle as well as the loaded steam Coal. But he could not able to produce any kind of documents in respect of the said Motor Cycle and the loaded steam Coal. We waited for reasonable time but none came to spot to produce any documents in respect of the said Motor Cycle loaded with steam Coal. So it is reasoned to belief that the rider & Owner of the said Motor Cycle in cahoots with others procured the said steam coal from Jharkhand state by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo, I seized Motor cycle having registration No. IH-01AC2178, Chassis No-MD20HDHZZSC005038, Engine No-DH101582 loaded with approx. 1.4 Quintal of steam coal after preparing proper seizure list in presence of available witnesses duly signed by them and also arrested the rider namely Bikash Kumar Mahato (23) S/o Naresh Mahato of village-Chitarpur, PS-Rajrappa, Dist-Ramgarh (Jharkhand) after informing him the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said seized articles to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the accused person namely Bikash Kumar Mahato (23) S/o Naresh Mahato of village-Chitarpur, PS-Rajrappa, Dist-Ramgarh (Jharkhand), (ii) The owner of the said motor cycle having registration No. JH-01AC2178, Chassis No-MD20HDHZZSC005038, Engine No-DH101582 & the other involved accused persons as they committed offence U/S- 379/411/413/414 of the IPC.
