Subject: Complaint regarding the physical assault on the Excise personnel and broken windscreen of the raiding vehicles of the Jhalda Excise Circle.

Respected Sir,

With due respect, I inform you that today i.e on 29-10-23 between 15.35 to 16.10 hrs on the basis of secret information I organized a raid programme at the 'Falguni Smriti Mela' which was held at the field area located between the villages Ronidih & Uhatu under the supervision Rabindranath Jit, D..E.C, Jhalda Range. The raiding team reached the spot and recovered the 60.0 ltrs of illicitly distilled liquor and seized the intoxicants for violation of Sec 18(i), 20 of the BE Act. 1909 as amended up to date which is punishable u/s 46A(c) of the same act vide SI's S.L No- 110/23-24 dt. 29-10-23 of Jhalda Excise Circle but no responsible person was arrested.

During the time of the raid, namely Swapan Mura, S/o: not known of Village: Uhatu , Sripada Mahato, S/o: not known of Village Udaysiru and some others persons (approx. 60 to 70 in nos) were attacking us and resisting to perform the Govt. duties by throwing stones, sticks and empty broken glasses haphazardly towards the raiding team and physically assaulting us. As a result our four Excise personnel namely (i) Totan Duary(Excise Constable), S/O; Tushar Kanti Duary Excise Constable, (ii) Sukumar Mahato (Excise Constable), S/O : Nilkamal Mahato, (iii) Madhab Kishku(Excise Constable), S/O :Damanci Kisku, (iv) Manik Gorain (Excise Constable), S/O :Chittaranjan Gorain were badly injured on the spot and also broken the windscreens of our raiding vehicles bearing Reg.no- WB-55A-5230 and WB-55B-0517. We complained to the organizer of 'Falguni Smriti Mela' named Joyram Mahato, S/o: Fagu Mahato of Vill : Mathari under PS : Jhalda but he did not cooperate with us. After that, we immediately medically examined our four injured Excise personnels at Jhalda BPHC and back to the Jhalda Excise Barrack.

So, I pray before you to register a case and take necessary action under proper section of law against the accused persons noted above.
